- Update from the Commission

The SCA took note of the update by the Commission on the latest market developments and on the implementation of the March package of support measures, of the delegations' suggestions and comments, and of the Commission's reaction.

Taking into account that, at the May Council, it was decided to discuss additional measures as well as additional EU funding at the June Council, the SCA will return to this topic on 20 June and invites the Commission to present initiatives at this SCA in preparation of the "Agriculture and Fisheries" Council on 27-28 June.

The Commission representative asked to put on record that the invitation foreseen in the above paragraph was not acceptable to his Institution.

While noting the possible abstention of one delegation, the SCA provided a preliminary positive reaction to the proposal for a Council Regulation amending Council Regulation 1370/2013. This proposal will therefore be put on the agenda of the SCA on 20 June and of the next Council for formal adoption.

The Presidency will submit a written report on the state of play on this file at the next SCA meeting on 20 June and this topic will be tackled at the "Agriculture and Fisheries" Council meeting on 27/28 June.

The SCA examined and welcomed the first version of draft Council conclusions on food waste and food losses. The Presidency took note of comments put forward by the delegations as well as by the Commission and gave the possibility to delegations to send their comments in writing by 15 June cob. Based on comments, the Presidency will prepare a revised version of the draft conclusions to be examined in the next SCA meeting on 20 June. The adoption of these conclusions is planned to take place at the "Agriculture and Fisheries" Council on 27/28 June.
