In Article 8(2):

- *read:* '2. The publication referred to in paragraph 1 shall be free of charge and in a machine-readable and human-readable format as defined in Article 14 of Commission Delegated Regulation (EU) .../... ¹² and in paragraphs (4) and (5) of Article 13 of Delegated Regulation (EU) .../....

Article 9, second paragraph:

for: 'This Regulation shall apply from the date referred to in the second paragraph of Article 55 of Regulation (EU) No 600/2014.'

read: 'It shall apply from 3 January 2018.'
