## Whereas:

- (1) The Convention on International Civil Aviation (the 'Chicago Convention') which regulates international air transport, entered into force on 4 April 1947. It established the International Civil Aviation Organization (ICAO). The Member States of the Union are Contracting States to the Chicago Convention and are members of the ICAO.
- (2) The Memorandum of Cooperation between the Union and the ICAO providing a framework for enhanced cooperation<sup>1</sup> (hereinafter referred to as the 'Memorandum of Cooperation') entered into force on 29 March 2012.
- (3) Pursuant to the Memorandum of Cooperation, the Joint Committee established therein may adopt annexes to the Memorandum of Cooperation.
- (4) At its next meeting, the EU-ICAO Joint Committee is expected to adopt a decision on the adoption of an Annex IV to the Memorandum of Cooperation, on capacity building, technical assistance, and implementation support. That new Annex IV is to provide for the establishment of a regular dialogue on capacity building, technical assistance, and implementation support activities, including training activities, in the areas covered by the Memorandum of Cooperation, with a view to achieving synergies and, where appropriate, to coordinating those activities.
