Subject:	Council Directive amending Directive 2006/112/EC as regards exemptions on importations and on certain supplies, in respect of Union measures in the public interest
	- Adoption of the legislative act

## I. INTRODUCTION

- 1. On 12 April 2021, the Commission presented a proposal for a Council Directive amending Directive 2006/112/EC on the common system of value added tax as regards exemptions on importations and on certain supplies, in respect of Union measures in the public interest (the so-called 'buy and donate' proposal)<sup>1</sup>.
- 2. The proposal aims to support measures taken at Union level in the public interest, in particular where the Union is acting in the execution of a mandate to buy goods and services in order to distribute them free of charge to Member States according to their emergency needs.

3. The European Economic and Social Committee issued its opinion on the proposal at its plenary session on 27 April 2021<sup>2</sup>. The European Parliament delivered its opinion on 18 May 2021<sup>3</sup>.

## II. COUNCIL DISCUSSIONS

- 4. After discussions in the Council preparatory bodies, the file was submitted to the Committee of Permanent Representatives on 9 June 2021 and to the Council (Economic and Financial Affairs) on 18 June 2021 for a policy debate<sup>4</sup>. The debate demonstrated the willingness of the Member States to reduce the scope of the proposal to the COVID-19 emergency and to delete the electronic exemption certificate from the proposal, to allow for a swift adoption of the draft Directive.
- 5. On 30 June 2021, the Presidency compromise text in doc. ST 9995/21 (+ REV 1 (FI)) was approved by the Committee of Permanent Representatives, subject to legal-linguistic revision. The Commission issued a statement to be included in the Coreper and Council minutes<sup>5</sup>.

## III. WAY FORWARD

6. Against this background, the Council (Economic and Financial Affairs) is invited to adopt the text in doc. 10114/21 (finalized by the lawyer-linguists) as an A-item in its meeting of 13 July 2021.
