1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 9987/17 FIN 350 SOC 464, accompanied by the corresponding proposal for transfer of appropriations No DEC 08/2017, as recorded in document 9989/17 FIN 351.

The proposal aims at mobilising an amount of EUR 1 002 264 under the EGF to meet an application from Spain to deploy the Fund in connection with 339 redundancies in five enterprises operating in the mining of coal and lignite sector. The redundancies are the result of a continuation of major structural changes in world trade patterns due to globalisation<sup>1</sup>.

The purpose of the proposed transfer is to move an amount of EUR 1 002 264 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 04 01 (*EGF- to support workers and self-employed persons whose activity has ceased as a result of the globalisation*).

- 3. The <u>Budget Committee</u> examined both proposals at its meeting on 16 June 2017.
- 4. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
  - adopt the draft Decision on the mobilisation of the EGF as set out in ANNEX 1;
  - approve the proposed transfer of appropriations;
  - approve the draft letter in ANNEX 2 to that effect.

# Proposal for a

## DECISION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL

of [...] 2017

on the mobilisation of the European Globalisation Adjustment Fund following an application from Spain – EGF/2017/001 ES/Castilla y León mining

THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1309/2013 of the European Parliament and of the Council of 17 December 2013 on the European Globalisation Adjustment Fund (2014-2020) and repealing Regulation (EC) No 1927/2006<sup>1</sup>, and in particular Article 15(4) thereof,

Having regard to the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management<sup>2</sup>, and in particular point 13 thereof,

Having regard to the proposal from the European Commission,

#### Whereas:

(1) The European Globalisation Adjustment Fund ('EGF') aims to provide support for workers made redundant and self-employed persons whose activity has ceased as a result of major structural changes in world trade patterns due to globalisation, as a result of a continuation of the global financial and economic crisis, or as a result of a new global financial and economic crisis, and to assist them with their reintegration into the labour market.

- (2) The EGF is not to exceed a maximum annual amount of EUR 150 million (2011 prices), as laid down in Article 12 of Council Regulation (EU, Euratom) No 1311/2013<sup>1</sup>.
- (3) On 20 January 2017 Spain submitted an application to mobilise the EGF, in respect of redundancies in the economic sector classified under the Statistical classification of economic activities in the European Community ('NACE') Revision 2 Division 5 (Mining of coal and lignite) in the region of Castilla y León. It was supplemented by additional information provided in accordance with Article 8(3) of Regulation (EU) No 1309/2013. That application complies with the requirements for determining a financial contribution from the EGF as laid down in Article 13 of Regulation (EU) No 1309/2013.
- (4) In accordance with Article 6(2) of Regulation (EU) No 1309/2013, Spain has decided to provide personalised services co-financed by the EGF also to 125 young people not in employment, education or training (NEETs).
- (5) In accordance with Article 4(2) of Regulation (EU) No 1309/2013, the application from Spain is considered admissible since the redundancies have a serious impact on employment and the local economy.
- (6) The EGF should, therefore, be mobilised in order to provide a financial contribution of EUR 1 002 264 in respect of the application submitted by Spain.
- (7) In order to minimise the time taken to mobilise the EGF, this decision should apply from the date of its adoption,

### HAVE ADOPTED THIS DECISION:

#### Article 1

For the general budget of the Union for the financial year 2017, the European Globalisation Adjustment Fund shall be mobilised to provide the amount of EUR 1 002 264 in commitment and payment appropriations.

#### Article 2

This Decision shall enter into force on the day of its publication in the Official Journal of the European Union. It shall apply from [the date of its adoption]\*.
