"Concernant la possibilité offerte aux autorités répressives d'effectuer des recherches alphanumériques dans la base de données Eurodac, la Belgique désire rappeler ses préoccupations légales, déjà avancées lors des négociations, et relatives au fait que cette fonctionnalité est uniquement proposée à des fins répressives, lesquelles sont définies dans le règlement comme étant un objectif secondaire, sans pour autant être prévue, sous conditions strictes conformément aux exigences de protection des données, pour la finalité migratoire qui constitue pourtant l'objectif principal du règlement Eurodac.

La Belgique considère que prévoir un accès alphanumérique pour les autorités migratoires aurait constitué une valeur-ajoutée dans le contexte du maintien de l'équilibre entre les finalités du règlement.

Néanmoins, en vue de parvenir à un accord sur cette partie importante de la réforme du Régime d'Asile Européen Commun, la Belgique peut soutenir le compromis de la Présidence tel qu'il est présenté dans le document 10079/17 du 12 juin 2017 et marque son accord pour que les trilogues commencent aussi tôt que possible."

Statement by the Czech Republic

"The Czech Republic would like to appreciate the effort of the Maltese Presidency in the preparation of the draft Action Plan on Drugs, particularly in the field of indicators and the connection of both legal and illegal substances.

However, we think that the Action Plan should better respond to the current evidence-based policy and should be able to effectively reflect and implement effort by one of the Member States to prevent the spread of epidemics.

According to the Czech Republic, it is important to create specific tools to respond effectively to challenges, in this case a network to strengthen cooperation to tackle the rising trend of stimulant addiction, in particular methamphetamine. Regarding the effective responses, the Action Plan should include recommendations to Member State governments for budgetary measures which should be the basis for National Action Plans.

The Czech Republic understands that it is a single country with serious problem with the production and use of methamphetamine, but there is a significant risk of massive spread to the whole of Europe.

In this regard, the Czech Republic would like to express dissatisfaction with this draft Action Plan on drugs, but will not oppose the adoption of this Action Plan."

Among the conduct described in sub-paragraphs (a), (c) and (d) of Art. 2 paragraph 1 of FD 2004/757, we think that Member States should be given the discretion if the conduct described under (c) – possession or purchase – should be criminalized or not. As the Directive contains minimum standards, any Member State is free to go further – but Member States should not be obliged, by virtue of Union Law, to criminalize such behaviour. Such a more limited approach of the Union legislator would be in line with the principle of subsidiarity in general and also with the conditions foreseen by the Treaties for legislating in criminal law:

"The European Parliament and the Council may, by means of directives adopted in accordance with the ordinary legislative procedure, establish minimum rules concerning the definition of criminal offences and sanctions in the areas of particularly serious crime with a cross-border dimension resulting from the nature or impact of such offences or from a special need to combat them on a common basis." (Art. 83 paragraph 1 TFEU) We think that the possession or purchase of new psychoactive substances in itself do not fulfil the cited (highlighted) criteria of the Treaty."
