#### Statement by the United Kingdom and Germany

"The United Kingdom and Germany support the Securitisation Regulation package that aims to free up capital for economic growth through simple, transparent and standardised securitisation.

However, it needs to be ensured that this package does not create unnecessary risks to financial stability. In particular, it needs to be ensured that the reversion of the Basel hierarchy of methods to calculate capital risk weights does not have a damaging effect on financial stability and the wider economy. In this respect, particular attention needs to be given to possible risks caused by the extension of the reversion of the hierarchy to non-STS securitisations.

We call on the European Banking Authority and the Commission to monitor closely the impact of the reversed hierarchy of methods on financial stability and other potential unintended consequences of the Regulation, taking immediate action where needed."

"Germany welcomes the unanimous adoption of the Omnibus Regulation in the Friends of Presidency Group (MFF) on 22 June 2017.

Germany points out that it supports the agreement in a spirit of compromise but that it reserves the right to return to individual questions in the future.

Germany is committed to the principle of sound financial management. Concerning the performance orientation of the EU budget Germany will continue to work for a greater consideration of the administrative burden. The success of performance oriented budgeting is still to be proven. Thus, spending reviews should play a stronger role than before.

Furthermore, Germany will continue to promote the need to take greater account of the specificities and requirements of shared management in federally organized Member States and to strengthen the voting weight of all Member States according to their de facto financing share in EU Trust Funds."

Déclaration conjointe de l'Espagne, la France et le Portugal

"La France, l'Espagne et le Portugal font de la lutte contre le blanchiment et le financement du terrorisme ainsi que contre les infractions financières, une priorité majeure.

C'est pourquoi elles soutiennent avec force la révision du Règlement du Parlement européen et du Conseil sur le contrôle d'argent liquide entrant et sortant de l'Union européenne. Ce projet prévoit en effet des avancées concrètes importantes pour régler les problèmes soulevés lors de l'application du règlement adopté en 2005 et pour renforcer ainsi le contrôle des flux financiers, en particulier en matière de définition de l'argent liquide, d'échanges d'information et de pouvoir de contrôle.

Le Portugal, l'Espagne et la France regrettent toutefois qu'à ce stade, la prise en compte des mouvements d'argent non accompagnés (article 4), envoyés par la poste, le fret-express ou un transporteur, n'ait pas conduit à la création d'une obligation déclarative préalable pesant sur l'expéditeur, mais simplement à une possible demande de divulgation en cas de découverte d'argent à l'occasion d'un contrôle. Cette rédaction, insuffisamment ambitieuse, crée de plus une distorsion avec l'obligation pesant sur les transferts accompagnés d'argent, soumis à une déclaration préalable obligatoire.

Cependant, compte tenu de l'importance de ce document, et afin de ne pas retarder les progrès déjà enregistrés dans ce projet, la France, l'Espagne et le Portugal ne s'opposent pas à son passage au Conseil en vue du prochain trilogue avec le Parlement Européen, qu'elles souhaitent rapide et très fructueux."

Statement by the Commission

"In light of the rules of the Treaties, a CFSP decision cannot be used as a means to confer power on the Council to enact a derogation from the procurement rules defined in the Financial Regulation given that such power is attributed to the Commission. Moreover, any derogation from the rules on participation in the procurement procedures of the mission cannot be of generic and unlimited nature and must be duly justified in each specific case. The Commission considers that the derogating provisions on procurement in the CFSP Decision can only be interpreted as a purely enabling clause. The Commission continues to exercise its competences in the implementation of the budget of the mission as stemming from the Treaties and in accordance with the rules and procedures of the Financial Regulation."
