- 1. On 7 June 2018 the Commission submitted to the Council the following proposals:
  - a) Proposal for a Regulation of the European Parliament and the Council establishing
    'Horizon Europe- The Framework Programme for Research and Innovation, laying
    down its rules for participation and dissemination'
  - b) Proposal for a Decision of the European Parliament and of the Council on establishing the **specific programme** implementing Horizon Europe the Framework Programme for Research and Innovation'<sup>2</sup>
  - c) Proposal for a Council Regulation establishing the Research and Training Programme of the European Atomic Energy Community for the period 2021-2025 complementing Horizon Europe – the Framework Programme for Research and Innovation<sup>3</sup>
- 2. The proposal for a Regulation establishing Horizon Europe is based on the TFEU Titles "Industry" and "Research and technological development and space" (Articles 173 and 182, 183 and 188) as the activities foreseen will fall under those covered by these Titles.
- 3. The proposal for a Decision establishing the Specific Programme that will implement Horizon Europe is based on the TFEU Titles "Industry" and "Research and technological development and space" (Articles 173 and 182) as the activities foreseen will fall under those covered by these Titles.
- 4. The proposal for a Regulation establishing the Research and Training Programme of the European Atomic Energy Community is based on Articles 4 and 7 of the Euratom Treaty.

- 5. Following Article 182 TFEU, the Framework programme and the specific programme are to be adopted by the European Parliament and the Council in accordance with the ordinary legislative procedure after consultation of the European Economic and Social Committee. Thus, the Opinion of the Committee of the Regions is not required. However, it should be recalled that the Committee of the Regions was consulted on the proposal for Horizon 2020 and its specific programme<sup>4</sup>. For the sake of consistency it therefore appears appropriate to also consult the Committee of the Regions on the present proposals.
- Following Article 7 of the Euratom Treaty, the Community research and training programme 6. is to be adopted unanimously by the Council. Thus the opinions of other institutions or bodies are not required. However, it should be recalled that the European Parliament and the European Economic and Social Committee were consulted on the proposals under Horizon 2020<sup>5</sup>. For the sake of consistency it therefore appears appropriate to also consult the European Parliament and the European Economic and Social Committee on the present proposal.
- 7 The Permanent Representatives Committee is therefore invited to decide, in accordance with Article 19(7)(h) of the Council's Rules of Procedure, to consult the Committee of the Regions, the European Parliament and the European Economic and Social Committee, respectively, on the above proposals and to request them to give their opinions as soon as possible.
