 Request for revised mandate for trilogue 10460/17 AGRILEG 114 CODEC 1085

Following the decision of the "Agriculture and Fisheries" Council on 12 June to continue the negotiations, the Presidency prepared, with the support of the Commission services, a revised compromise text. This new document was presented to the SCA for approval, in order to finalise the negotiations with the European Parliament.

The SCA supported the compromise text submitted by the Presidency (document 10460/17) with three modifications. The first modification refers to Annex Va, which is deleted. The two other modifications concern article 35 and the practice of growing crops in demarcated beds (Room documents distributed during the meeting can be found in the annexes to WK 7504/17).

A large number of delegations supported this new mandate. Seven delegations (CY, FI, DK, CZ, LT, SK, AT) voted against and four delegations abstained (BE, PL, LV, HU).

On the basis of this mandate, a trilogue took place on 28 June 2017.
