 - State of play

The SCA took note of the comments made by delegations and the Commission. Regarding the first question addressed to MS in the "flash", the progress report (doc 10195/16) was considered a good basis for further work but some specific issues need further consideration. On the second question, some delegations showed some flexibility regarding the structure of the Regulation. Other delegations preferred to stick to the General Approach. Some delegations voiced the need of an examination at Working Party level of the more technical elements of the dossier. The Presidency took note of the preliminary orientations given by the SCA and asked delegations to submit written contributions to the Presidency / GSC by 20 July. The SCA will re-examine the dossier in September.
