STATEMENT BY THE MEMBER STATES

"The Member States:

- welcome the signature of the Protocol to the Agreement with the Principality of Monaco
 providing for transparency and exchange of information measures equivalent to those
 applicable in the EU and compliant with the global standard for automatic exchange of
 information, and recognise its importance at international level;
- commit to implement this Protocol within the timescale provided for, in an efficient and reciprocal manner;
- commit to analyse the situation of the Principality of Monaco in the light of the measures provided for in this Protocol and to take it into account in their bilateral relations with the Principality."
