## NOTE VERBALE

The Mission of the Kingdom of Norway to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honour to refer to the Agreement between the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, signed on 18 May 1999.

In accordance with Article 8 of the Agreement referred to above, the Mission of the Kingdom of Norway to the European Union hereby notifies, on behalf of the Government of Norway, that Norway accepts the content of the following acts, but that, according to Article 8 paragraph 2 (c), the content of these acts can become binding for Norway only after the fulfilment of constitutional requirements:

- *Regulation (EU) 2017/2225 of the European Parliament and of the Council of 30 November 2017 amending Regulation (EU) 2016/399 as regards the use of the Entry/Exit System*

Furthermore, the Mission of Norway to the EU hereby reconfirms the notification provided on the 16th of April 2019 to Protocol concerning the following acts:

- *Regulation (EU) 2017/2226 of the European Parliament and of the Council of 30 November 2017 establishing an Entry/Exit System (EES) to register entry and exit data and refusal of entry data of third-country nationals crossing the external borders of the Member States and determining the conditions for access to the EES for law enforcement purposes, and amending the Convention implementing the Schengen Agreement and Regulations (EC) No 767/2008 and (EU) No 1077/2011,*
- *Regulation (EU) 2018/1240 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 12 September 2018 establishing a European Travel Information and Authorisation System (ETIAS) and amending Regulations (EU) No 1077/2011, (EU) No 515/2014, (EU) 2016/399, (EU) 2016/1624 and (EU) 2017/2226.*

In accordance with Article 8 referred to above, the Mission of the Kingdom of Norway to the European Union hereby notifies, on behalf of the Government of Norway, that Norway accepts the content of the following acts according to Article 8 paragraph 2 (c):

- Regulation (EU) 2018/1806 of the European Parliament and of the Council of 14 November 2018 listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement (codification).
- Commission Implementing Decision of 30.8.2017 establishing the list of supporting documents to be submitted by applicants for short stay visas in Australia, Bangladesh, Ethiopia, South Africa, Thailand and Zambia.
- Council Decision (EU) 2017/1908 of 12 October 2017 on the putting into effect of certain provisions of the Schengen acquis relating to the Visa Information System in the Republic of Bulgaria and Romania.
