# II. ADOPTION OF LEGISLATIVE ACTS FOLLOWING THE EUROPEAN PARLIAMENT'S SECOND READING

European Parliament legislative resolution of 5 October 2020 on the Council position at first reading with a view to the adoption of a regulation of the European Parliament and of the Council on European crowdfunding service providers for business, and amending Regulation (EU) 2017/1129 and Directive (EU) 2019/1937 (06800/1/2020 – C9-0292/2020 – 2018/0048(COD))

#### (Ordinary legislative procedure: second reading)

The European Parliament,

- having regard to the Council position at first reading (06800/1/2020 C9-0292/2020),
- having regard to the opinion of the European Economic and Social Committee of 11 July 2018<sup>2</sup>,
- having regard to its position at first reading<sup>3</sup> on the Commission proposal to Parliament and the Council (COM(2018)0113),
- having regard to Article 294(7) of the Treaty on the Functioning of the European Union,
- having regard to the provisional agreement approved by the committee responsible under Rule 74(4) of its Rules of Procedure,
- having regard to Rule 67 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on Economic and Monetary Affairs (A9-0168/2020),
- 1. Approves the Council position at first reading;
- 2. Notes that the act is adopted in accordance with the Council position;
- 3. Instructs its President to sign the act with the President of the Council, in accordance with Article 297(1) of the Treaty on the Functioning of the European Union;
