# OF THE JOINT COUNCIL ESTABLISHED UNDER THE ECONOMIC PARTNERSHIP AGREEMENT BETWEEN THE EUROPEAN UNION AND ITS MEMBER STATES, OF THE ONE PART, AND THE SADC EPA STATES, OF THE OTHER PART

on the adoption of trigger levels for products eligible for safeguard measures and marked with an asterisk, in accordance with footnote 1 of Annex IV of the Agreement

THE JOINT COUNCIL,

Having regard to the Economic Partnership Agreement between the European Union and its Member States, of the one part, and the SADC EPA States, of the other part ('the Agreement'), and in particular Articles 35 and 102 thereof, and to Decision No 1/2019 of the Joint Council (Rules of Procedure of the Joint Council).

HAS ADOPTED THIS DECISION:

Article 1

Pursuant to footnote 1 of Annex IV of the Agreement, the reference quantities for the product marked by an asterisk are adjusted, for the purposes of Article 35 of the Agreement, in accordance with the Annex to this Decision.
