THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 100(2) in conjunction with point (a) of the second subparagraph of Article 218(6) thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- (1) In accordance with Council Decision (EU) 2019/1580¹, the Agreement with Respect to Time Limitations on Arrangements for the Provision of Aircraft with Crew between the European Union, the United States of America, Iceland, and the Kingdom of Norway ('the Agreement')² was signed on 27 August 2019, subject to its conclusion at a later date. The Agreement, which is attached to Decision (EU) 2019/1580 together with the Memorandum of Consultations³, has been applied on a provisional basis since the date of signature thereof.
- (2) The Agreement has been signed in English. Pursuant to Union law, the Agreement has also been drawn up in other official languages of the Union as provided by Decision (EU) 2019/1580. Those addititional language versions should also be authenticated by the Parties.
- (3) The Agreement should be approved,

Article 1

The Agreement with Respect to Time Limitations on Arrangements for the Provision of Aircraft with Crew between the European Union, the United States of America, Iceland, and the Kingdom of Norway, of which the Joint Declaration forms an integral part, is hereby approved on behalf of the Union.¹

Article 2

Notwithstanding the fact that the English-language version of the Agreement has been signed, Bulgarian, Croatian, Czech, Danish, Dutch, Estonian, Finnish, French, German, Greek, Hungarian, Italian, Latvian, Lithuanian, Maltese, Polish, Portuguese, Romanian, Slovak, Slovenian, Spanish and Swedish language versions are to be authenticated by means of an exchange of letters between the Parties. All authenticated versions shall be of equal value.

Article 3

The President of the Council shall, on behalf of the Union, give the notification provided for in Article 7(1) of the Agreement².
