#### STATEMENT BY THE COMMISSION

"The Commission disagrees with the addition of Article 192(1) TFEU to the legal basis of the Council Decision. The Commission reiterates its view that the only appropriate legal basis is Article 207 TFEU, in conjunction with Article 218(9)TFEU."
