Subject:	Draft REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on a Single Market For Digital Services and amending Directive 2000/31/EC (Digital Services Act) (first reading)
	- Adoption of the legislative act

- 1. On 16 December 2020 the <u>Commission</u> sent its proposal<sup>1</sup>, based on Article 114 TFEU, to the Council.
- 2. The <u>European Data Protection Supervisor</u> delivered its opinion on 10 February 2021<sup>2</sup>.
- 3. The <u>European Economic and Social Committee</u> delivered its opinion on 27 April 2021<sup>3</sup>.
- 4. The <u>Committee of the Regions</u> delivered its opinion on 30 June 2021<sup>4</sup>.

- 5. On 5 July 2022 the <u>European Parliament</u> adopted its position at first reading on the Commission proposal. The Parliament having approved a corrigendum to that position at its plenary session of 12 to 15 September 2022, the outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council<sup>5</sup>.
- 6. The statement of the <u>Commission</u> for the minutes of the Council is set out in the <u>Addendum 1</u> to this note. The statement of <u>Denmark</u> for the minutes of the Council is set out in the Addendum 2 to this note.
- 7. The <u>Permanent Representatives Committee</u> is therefore asked to:
  - confirm its agreement and to suggest that the <u>Council</u> approve the European
    Parliament's position, as set out in PE-CONS 30/22, as an "A" item at a forthcoming meeting;
  - decide that the Commission's statement, as set out in the Addendum 1 to this note, to be
    published in the C series of the Official Journal of the European Union.
- 8. If the <u>Council</u> approves the European Parliament's position, the legislative act will be adopted.

After being signed by the Presidents of the European Parliament and of the Council, the legislative act will be published in the *Official Journal of the European Union*.
