<u>The SCA</u> discussed the above mentioned report and is of the view that, in case a change of policy objectives in relation to farmers' incomes would require a change in data collection methods, then such change should be the result of political and legislative decision-making while giving due consideration to the impact of any change in data collection methods on the administrative burden.

The representative of the CLS presented the information note on the judgment in Case C-113/14 (doc 12284/16), stressing that, in addition to the immediate consequences of the judgment, for the future it would be important for the Council's prerogatives to be respected in relation to all measures falling within the scope of Article 43(3) TFEU, in particular measures on fixing prices and aid. The SCA took note of these explanations and those of the Commission representative, as well as of delegations' questions and comments.
