Statement by United Kingdom

"The UK has no objections to the current text of the non-binding Joint Way Forward and is grateful to the Commission for seeking further assurances on the content. Although not objecting to the text, the UK remains concerned that the JWF goes beyond its description of high level supporting framework and goes into levels of operational detail that are unhelpful for some EUMS e.g. travel documentation required (Part II, paragraph 2) and visas for escorts (Part II, paragraph 5).

The UK would like to recall the Council's invitation to the Commission in its Council Conclusions on returns (9 June 2016) "to ensure that effective consultation mechanisms are in place and that coordination takes place (...) with the aim that the interests of Member States, and the views of their operational and policy experts are fully taken into account in the negotiations and dialogues with third countries". We hope adequate consultation of Member States, and their practitioners' networks, will take place before engaging with any other country on returns and readmission."

#### Statement by Portugal

"On the basis of the respect of the competences allocated between the European Union and its Member States, as defined by the Treaties, the Decision of the Council that authorizes the provisional application, by the EU, of the Framework Agreement between the European Union and its Member States, of the one part, and Australia, of the other part, shall not affect the autonomy of decision of Portugal on the issues of its national competence, whose decision to be bound by the Agreement depends on the conclusion of the internal ratification procedures and on the entry into force of the agreement in the international legal system, in accordance with the Constitutional principles and rules."

### Statement by Romania

"Romania underlines the importance of the Framework Agreement in consolidating and deepening the political dialogue and cooperation in various fields of mutual interest between the European Union and Australia.

Romania recalls the EEAS' commitment to raise at the level of the Joint Committee to be established by the Agreement, aspects of particular interest highlighted by several Member States during the negotiation process of the Agreement, among which the importance of ensuring full visa reciprocity, as highlighted by Romania.

We underline that this issue remains a priority and a matter of concern for Romania, considering that Australia continues to apply a different treatment for Romanian citizens in the process of visa granting, translated into a significantly lower rate of autogrant visa in the case of Romanian citizens compared to the other EU citizens.

We expect the EEAS to raise our concerns within the Joint Committee after the signing of the Agreement and inform us accordingly on the outcome of the discussions."
