Statement by the United Kingdom

"While the United Kingdom can support the adoption of the Council Decision authorising the negotiation at UNCITRAL on both a Model Law and a Convention dealing with the enforcement of international commercial settlement agreements, like a number of other Member States it does not accept that the case has been made for there being EU exclusive competence in this area.

In addition, in accordance with the provisions of Protocol 21 to the Treaties, the United Kingdom has notified the President of the Council that it wished to take part in the adoption of this Decision, and considers the inclusion of the word "therefore" in the text of Recital 6 to be inaccurate. The fact that the United Kingdom is taking part in Regulation 1215/2012 does not, in its view, render inoperative the provisions of Protocol 21."

#### Statement by Germany

"Negotiations on the enlarged Partnership and Cooperation Agreement between the EU and the Kyrgyz Republic should take place only after the presidential elections. This will allow for a more flexible approach, especially in case of serious shortcomings during the election. In the event of a major democratic setback, the discussion in the COEST should be reopened."

#### Statement by the Commission

"The Commission considers that the "Decision of the Representatives of the Governments of the Member States, meeting within the Council authorising the European Commission to open negotiations, on behalf of the Member States, on the provisions that fall within the competence of the Member States, of a Comprehensive Agreement between the European Union and its Member States, of the one part, and the Kyrgyz Republic, of the other part" is unwarranted because the Commission aims to conduct Comprehensive Agreement negotiations with the Kyrgyz Republic exclusively within the framework of the EU competencies as defined by the Treaty on European Union and the Treaty on the Functioning of the European Union."

#### Statement by Estonia

"Estonia strongly supports the adoption of the electricity balancing guideline. However, we note that in the Estonian language version of the Commission regulation an incorrect translation of the term "*balance*" is used. The terms that have been traditionally used in national legal acts (Electricity Market Act, Grid Code) and by market participants in their standard terms and conditions are "*bilanss*" and "*reguleerimis-*". We strongly believe that introducing novel terms in the electricity balancing guideline will lead to legal uncertainty and cause undue administrative burdens. Therefore, we urge the Commission to reconsider and introduce a translation of the term "*balance*" that is consistent with Estonian national legislation as well widely understood by market participants."
