<u>The Council</u> approved the European Parliament's position at first reading and the proposed act has been adopted, with the <u>Polish Delegation</u> voting against, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. In accordance with the relevant Protocols annexed to the Treaties, <u>the Danish</u>, <u>Irish and the United Kingdom delegations</u> did not participate in this vote. (Legal basis: Article 79(2)(c) of the TFEU).

# **Statement by France**

"France welcomes the objective of harmonising and providing legal safeguards for the European travel document for the return of illegally staying third-country nationals. As regards the application of Article 4 of the Regulation, France takes note of the assurance it has been given by the Commission that it can continue to send the individual information and the signature and stamp of the competent authority electronically to the authorities responsible for implementing the return measures, to be printed locally on the blank pages in accordance with the new technical security specifications."

# **Statement by Poland**

"Poland does not support the so-called "compromise" presented for adoption at the Council meeting on 13 October 2016. We feel that an appropriate compromise taking due account of the interests of both Member States and suspected and accused persons was expressed in the general approach text adopted by the Council in February 2015. The present draft is in fact an unwarranted concession to the European Parliament and made by it without regard to the overall impact of this document and its internal consistency. Poland cannot in particular support the extension of the draft directive beyond its intended scope of temporary legal aid, the exclusion of specific provisions relating to less serious offences and the obligation to provide legal aid in the state issuing an EAW."

The Council held a policy debate on the Eurodac Regulation and on the EU Asylum Agency Regulation on the basis of the Presidency's note in 12726/16. <u>A large majority of delegations</u> supported the Presidency suggestions, based on the results of discussions at Working Party level.

The Council found broad conceptual support for the Articles on judicial review, cooperation with third countries and international organizations, cooperation with non participating Member States and cooperation with Eurojust as outlined in 13185/16. Some work on these provisions will continue at expert level. Following an extensive debate on the full text of the draft Regulation and taking into account the Commission's cost/benefit analysis, the Presidency received clear support to finalise the full text for the December Council. The experts and high level advisors would aim to solve the outstanding issues listed by the Ministers.
