The SCA took note of the outcome of the fourth trilogue on the agricultural provisions of the Omnibus proposal as reflected in document 13057/17, the fourth column of the tables annexed to documents 11247/4/17 REV 4, 11274/5/17 REV 5, 11290/4/17 REV 4 and 11291/4/17 REV 4 and the consolidated texts set out in documents 13053/17, 13056/17, 13176/17 and 13177/17. It endorsed that outcome, subject to a silence procedure running until 18 October 2018.

It also took note of the explanations provided by the Commission (see [Annex 1](#)) in response to certain delegations' questions and the statement by the French delegation (see [Annex 2](#)).

In addition, it noted the information provided by the Presidency and the Commission regarding the next steps.

#### **4. Organisation of future work**

**EXPLANATIONS BY THE COMMISSION**1. Land lying fallow for EFA purposes:

The Commission confirms that it does not intend to amend Article 45(2) of Delegated Regulation (EU) No 639/2014, which currently reads as follows: "By way of derogation from Article 4(1)(h) of Regulation (EU) No 1307/2013, land lying fallow for the purpose of fulfilling the ecological focus area for more than 5 years shall remain arable land".

The amendments to Regulation (EU) No 1307/2013 agreed in the context of the Commission's Omnibus proposal do not affect the derogation set out in the said Article 45(2), and the Commission still wants to incentivise farmers to declare fallow land EFAs.

2. Control and retroactive application of the ploughing provision:

The Commission confirms that under normal circumstances it can be assumed that the change of species (e.g. from grass to clover-grass and vice versa) is an outcome of ploughing up a parcel. Nevertheless, the change concerned has to be indicated explicitly by the farmer in his annual aid application. Moreover, the species concerned should lead to a clear distinction in the grass succession, for example grass species converted into mixture of leguminous and grasses.

3. AM 83

As regards the modification of Article 45(3) of Regulation (EU) No 1307/2013 proposed by the Council, the Commission confirms that some flexibility already exists under the current rules. According Article 44 of Delegated Regulation (EU) No 639/2014, when there is a decrease of the ratio by more than 5 %, Member States have to determine the range of farmers subject to the reconversion obligation. For this purpose, as specified in chapter 5.2.2 of DG AGRI's guidance document on the implementation of permanent grassland by Member States, Member States can establish their own criteria to target certain categories of producers.

*Dans un souci de compromis, la France a donné son accord au paquet présenté par la présidence. Concernant le règlement OCM en particulier, la France salue l'accord trouvé entre le Parlement et le Conseil, qui vise à renforcer le positionnement des agriculteurs dans la chaîne d'approvisionnement alimentaire ;*

*La France regrette toutefois l'absence d'avancée sur deux points :*

*- sur le règlement de développement rural, malgré l'accord des deux co-législateurs, l'amendement permettant de cibler l'indemnité compensatoire de handicaps naturels, sur la base de critères objectifs et non discriminatoires, a dû être retiré. Cet amendement était pour autant en phase avec les objectifs assignés au règlement de développement rural et aurait permis de disposer de la souplesse nécessaire à l'atteinte de ces objectifs ;*

*- concernant les paiements directs, l'assouplissement du verdissement est en contradiction, d'une part, avec les attentes des citoyens européens telles qu'elles ressortent de la consultation publique organisée par la Commission européenne au 1<sup>er</sup> semestre 2017 sur l'avenir de la PAC et, d'autre part d'une façon plus générale, avec l'ambition portée par l'Union en matière de développement durable.*

**Declaration of the French Authorities

*With a view of reaching an agreement, France supports the package presented by the Presidency. Concerning the CMO regulation, France especially welcomes the agreement reached between the Parliament and the Council, which aims to strengthen the position of farmers in the food supply chain ;*

*However France regrets the lack of progress on the two following points :*

*- concerning the rural development regulation, France regrets that, despite the agreement of the two co-legislators, the amendment allowing an additional target for the compensatory allowance of natural handicaps, on the basis of objective and non-discriminatory criteria, was withdrawn at the end of the discussions. The amendment brought the flexibility necessary to achieve the objectives of the Rural Development Regulation ;*

*- concerning the direct payments regulation, France regrets the easing of greening, which is contrary to, on the one hand, the expectations of European citizens according to the results of the public consultation conducted by the European Commission in the first half of 2017 on the future of the CAP and on the other hand, the environmental ambition of the European Union concerning sustainable development.*
