Statement by the Commission

"The Commission regrets that COREPER decided to not continue discussing the proposed Council Decision on the position to be adopted on behalf of the European Union in the IMO on the approval and adoption of the amendments to MARPOL Annex I concerning the designation and taking effect of the Baltic Sea and North Sea as NECAs.

The Commission is of the view that the proposed amendments to Annex VI of the MARPOL Convention may affect existing EU acquis in the area of protecting and preserving air and water quality as well as human health and provisions related to the internal market. The Commission therefore takes the view that the Council is under the obligation to establish the position to be taken and to use the procedure set out in Art. 218(9) to ensure a coordinated Union position that sends a politically strong, transparent and unified message to IMO which also corresponds to the impact of the political decision.

The Commission reserves its position and reserves itself the right to have recourse to all means available under the Treaty."

"In line with the position defended in case C-626/15, the Commission cannot agree with the Council's conclusion that the proposals on conservation measures establishing the Weddell Sea Marine Protected Area (WSMPA), the East Antarctic Representative System of Marine Protected Areas (EARSMPA), time-limited Special Areas for Scientific Study in newly exposed marine areas following ice shelf retreat or collapse in Subarea 48.1, Subarea 48.5 and Subarea 88.3. and the Ross Sea Region marine protected area (RSRMPA) by the Commission for the Conservation of Antarctic Marine Living Resources (CCAMLR) should be submitted or supported by the European Union and its Member States, as these measures fall, in view of their aim, content and context, within the Union's exclusive competence for the conservation of marine biological resources (Article 3(1)(d) TFEU).
