	- Roadmap

Delegations will find below the above-mentioned roadmap as presented by the Presidency and the incoming Presidency.

Following established practice, the Presidency and the incoming Presidency have prepared this roadmap on the 2016 European semester. The roadmap outlines all key steps of the 2016 semester and, where appropriate, provides preliminary indications on the focus of discussions.

The objectives of the roadmap are to ensure that all relevant Council formations, and their preparatory bodies, work in a coordinated and consistent manner towards a thorough preparation of the European Council debates on the European semester and to enable the General Affairs Council and COREPER to oversee the process.

The roadmap is divided in two phases: the first, with more details, until the March European Council, and the second, more indicative, for the period between the European Council meetings in March and June 2016. An updated roadmap will be presented in the spring of 2016, as appropriate.

The incoming Presidency will approach the European semester in a holistic manner, addressing the Annual Growth Survey package together with the issue of implementation of Country-specific recommendations (CSRs). Spring Councils will devote specific attention to cross-examination of best practices and bottlenecks in implementing Country-specific recommendations. This will enable ministers to examine how EU level guidance and conclusions are translated into national action and how this could be further improved.

The reforms foreseen in the Five Presidents' report on Completing Europe's Economic and Monetary Union pertaining to the European semester will be discussed within the Council in parallel to the European semester itself. The Presidency and the incoming Presidency will ensure the necessary interlinkages.

The incoming Presidency is initiating discussions with the chairs of the Committees (EFC, EPC, EMCO, SPC) and the Chair of the HLG-COMPCRO with a view to coordinating the management of their work throughout the semester. The incoming Presidency will keep COREPER informed.

The Presidency and the incoming Presidency acknowledge the parliamentary dimension, both at national and European level, of the European semester and take note of the intention for a Joint debate on the European semester with the European Parliament foreseen for March 2016.
