After consideration of two amendments tabled by the Belgian and Dutch delegations respectively and subject to the usual lawyer-linguist revision, <u>the SCA</u> could endorse the proposal for a Council Regulation as amended on the basis of the amendment tabled by the Dutch delegation.

<u>The SCA</u> took note of the comments of the Council Legal Service, as well as of the Commission, and its intention to table a statement reflecting its commitments regarding the review and possible revision of the reference thresholds, and of delegations' comments. The General Secretariat was asked to amend the text of the proposal as agreed during the meeting (see doc. 14143/16 + COR 1) and to ensure its linguistic revision in order to allow for the adoption of this Regulation by the Council before the end of the year.

<u>The SCA</u> took note of the report from the Working Party on organic farming that took place on 25 October and endorsed the Presidency orientations outlined in document 13737/16. In addition, the SCA gave guidance on three issues highlighted by the Presidency in document 13737/16 and in its flash. On *greenhouses*, many delegations could support the Presidency position (General Approach + DA). Regarding the *EP non-paper on seeds*, a number of delegations was sceptical about the substance of the non-paper, while some other delegations could support the part on heterogeneous material; many delegations would prefer to see the issue on seed regulated in the horizontal regulation on seeds and not in the organic regulation. On *database on livestock*, many delegations could not support the creation of such database.

The Presidency took note of the comments made by delegations and the Commission. The Presidency will take on board the orientations given by the SCA in view of the future negotiations.

<u>The Presidency</u> informed the SCA on the organisation of the "Agriculture and Fisheries" Council meeting on 14/15 November 2016 and on the preparation of the SCA meeting on 21 November 2016.
