The Council held its first annual rule of law dialogue. All Member States were invited to share one best practice and one challenge together with a possible solution in the field of rule of law at national law. Member States were also invited to react to the Presidency paper on rule of law in the era of digitalisation. The Netherlands delegation will organise a second dialogue in May 2016. The Slovakian delegation will evaluate during its Presidency the experience acquired on the basis of this dialogue, as foreseen in the 2014 conclusions of the Council and the member states meeting within the Council on ensuring respect for the rule of law.

<u>The Commission</u> presented the outcomes of its first annual colloquium on fundamental rights.

#### STATEMENT BY HUNGARY

"Hungary firmly believes that the objectives of cohesion policy are firmly anchored in the Treaty on the Functioning of the European Union, and these objectives remain valid even at the time of the migration crisis. Therefore it is clear that cohesion policy resources, including those of the European Territorial Objective goal, should first and foremost contribute to these Treaty objectives, as well as to the European Strategy for growth and jobs, and not tackling the symptoms of the migration crisis."
