	- Adoption of the legislative act

- 1. On 1 June 2018, the Commission sent its proposal¹, based on Article 43(2) TFEU, to the Council.
- The European Economic and Social Committee delivered its opinion on 17 October 2018². 2.
- 3. The Court of Auditors delivered its opinion on 25 October 2018³.
- The Committee of the Regions delivered its opinion on 5 December 2018⁴. 4.

- 5. On 23 November 2021, the <u>European Parliament</u> adopted its position at first reading on the Commission proposal. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council⁵.
- 6. The <u>Special Committee on Agriculture</u> is therefore asked to confirm its agreement and to suggest that the <u>Council</u>:
 - approve the European Parliament's position, as set out in PE-CONS 65/21⁶, as an
 "A" item at a forthcoming meeting;
 - approve the statement by the Council, set out in the <u>Addendum 1</u> to this note;
 - approve the joint statement by the European Parliament, the Council and the
 Commission, set out in the <u>Addendum 2</u> to this note;
 - decide that the statements set out in the <u>Addenda 1 and 2</u> to this note be published in the
 C series of the *Official Journal of the European Union*;
 - decide that the Commission's statements and the joint statement by the European
 Parliament and the Commission set out in the <u>Addendum 4</u> to this note be published in the C series of the *Official Journal of the European Union*;
 - take note of the statement by the European Parliament set out in the <u>Addendum 5</u> to this note, to be published in the C series of the *Official Journal of the European Union*.
- 7. The statements for the minutes of the Council are set out in the Addenda 1, 2, 3 and 4 to this note.
