The Committee noted the very broad support for the line to take as proposed by the Commission and endorsed the EU positions as set out in the above mentioned documents.

<u>The Commission representative</u> stated that the EU has a special responsibility to act on the worrying scientific advice on Mediterranean Swordfish, being accountable for most of the catches. In order to be in line with the recommended reduction of 57%, the Commission proposes from 2018 to introduce a -25% TAC (gradually decreasing 5% per year over 5 years) and a series of technical measures. This would be a credible position of the EU at the ICCAT Special meeting. In relation to Eastern bluefin tuna, he recalled that new advice is programmed for 2017, current rules foresee a 20% increase of the TAC in 2017, and strongly warned against the counterproductive effects of reopening this issue already this year.

<u>The Italian delegation</u> did not dispute the need to address the stock situation of Mediterranean Swordfish but could not support the proposal because of envisaged reduction which is excessive in the light of the uncertainty over the future allocation key. An increase of the Bluefin tuna TAC would be a way to make the Swordfish proposal more acceptable because of its socio-economic consequences. <u>The Spanish delegation</u> could support the EU position, except on Bluefin tuna where it wanted a further TAC increase in 2017. Likewise, it sought an increase for Northern Albacore. Science has confirmed the recovery of bluefin tuna and would also allow for an increase for Northern Albacore. <u>The Portuguese delegation</u> also subscribed to the Spanish view on these two species. <u>The Croatian delegation</u> agreed that a further increase for Bluefin tuna would not compromise its recovery.

<u>The French delegation</u> acknowledged the immediate hard consequences of the Mediterranean Swordfish proposal, but underlined that the efforts would pay off in the longer term as it had done with Bluefin tuna. However, it wished to see a Commission statement that the provisions for fleets with very small catches will be proportionate and adequate. <u>The Cyprus, Croatian</u> <u>and Slovenian delegations</u> also wished to see such a statement while <u>the Spanish and Italian</u> <u>delegations</u> were not supportive.

<u>The Greek delegation</u> wanted it on record that, internally in the EU, a revision of historic catch data needed to be reviewed.

Statement by the Commission

"This proposal for a Recovery plan for Mediterranean swordfish takes fully into consideration the specificities of small scale and artisanal operators by providing additional flexibility and exemptions, particularly in the area of control requirements.

In the context of the possible implementation of a TAC for Mediterranean Swordfish, at the EU level in 2018, special consideration should be given to the impact of a TAC reduction for the Member States with annual catches (including bycatches) below 100 t. This will be reflected in the EC proposal for the 2018 TAC & Quota Regulation."

Statement by Ireland

"Ireland wishes to recall that the stated aims of Directive 2009/45/EC of the European Parliament and of the Council on safety rules and standards for passenger ships is for the attainment of a high level of safety and at removing barriers to trade, by setting harmonised safety standards at an appropriate level for passenger ships and craft operating domestic services.

Currently offshore service vessels are within the scope of the EU passenger ship directive and by removing them as proposed in this refit exercise Ireland is of the view that the aims of the directive will not be achieved. That is to say there will be a reduction in the safety of personnel transported on such ships and there will be barriers to trade introduced by removing the harmonised safety standards.

We have always considered that any ship constructed of steel, or equivalent and carrying more than twelve passengers engaged on domestic voyages is within the scope of the Directive on domestic passenger ships. This is particularly the case when the people being carried are being taken to or from their place of work.

Of course we do agree that the specially trained industrial personnel being transported are not the same as members of the general public. Ireland also acknowledges that the arrangements of the ships transporting them may require special consideration to fulfil their purpose. However the fundamental issue is that industrial personnel being transported on offshore service vessels are passengers and anything which leads to them being treated as a new category of person on-board ships will potentially introduce considerable uncertainty in the long established maritime regulatory framework where there are only two such categories i.e. seafarers and passengers.

We also consider that the definition of an offshore service vessel in the proposed directive is so wide that it could be used by unscrupulous operators to exempt large amounts of domestic passenger ships and this would have significant adverse maritime safety consequences. We are of the view that the objective of facilitating the development of the sector is best achieved by introducing industrial personnel as a category of passenger and that such ships are passenger ships but that they can have special consideration applied to them. This will achieve the aims of the directive for a high level of maritime safety and the reduction in barriers to trade."

Statement by Ireland and Germany

"The stated aims of Directive 2009/45/EC of the European Parliament and of the Council on safety rules and standards for passenger ships is for the attainment of a high level of safety and the removal of barriers to trade, by setting harmonised safety standards at an appropriate level for passenger ships and craft operating domestic services.

However, Ireland and Germany consider that the Refit proposal does not achieve these goals. This is because the refit exercise removes sailing ships from the scope of the directive and it thus removes the harmonised safety standards and consequently introduces barriers to trade. The safety of sailing ships continues to be a major safety concern. There have been several high profile and very serious maritime casualties involving such ships including recently the Sail Training Vessel "Astrid" which sank of the coast of Ireland. Fortunately due to heroic rescue efforts all of the young passengers and crew on-board were rescued. The report of this casualty was published by the Marine Casualty Investigation Board of Ireland and all are encouraged to read this to see how close we came to a major maritime tragedy. This report highlighted many of the grave safety concerns associated with such ships and we should take this as a warning to urgently address the safety of these ships which carry so many young people. It is also notable that the casualty with the "Astrid" occurred when it was using its engine and so we consider that there is no justification for attempts in the proposed Refit to make a distinction between ships with sails and an engine and ships with just an engine as it is well known that these so-called sailing ships use their engines for significant amounts of time, even when under sail. The European public will not forgive us if there is a tragedy with such ships.

Additionally, Ireland and Germany highlight that removing such sailing ships from the scope of the directive will introduce barriers to their use throughout the EU as the existing harmonised standards will be replaced by a mix of varying national requirements. This will have an adverse impact on the use of such ships in cultural events such as tall ship races. It will also adversely impact in the market for the supply and sale of such ships. It is also to be noted that such sailing ships fitted with an engine are within scope of the IMO SOLAS convention and are required to hold an international passenger ship safety certificate for international voyages between EU member states. This will not change if the refit amendments are adopted. As such sailing ships are within the scope of SOLAS, the EU Directive on Port State Control 2009/16/EC applies and they must be inspected in accordance with this Directive and entered into Thetis. Therefore, there is nothing to be gained by removing these ships from the Refit directive as doing so reduces maritime safety and introduces barriers to trade for such ships."

Statement by the Commission

- "1. The Commission takes note of the intention of the Council to adopt a decision to authorise the Commission to open negotiations with Armenia as regards matters falling within the exclusive Union competence. At the same time the Representatives of the Governments of the Member States, meeting within the Council, have the intention to adopt a decision authorising the European Commission to negotiate on behalf of the Member States on matters that do not fall within the exclusive Union competence.
- 2. The Commission considers that the Union is competent to negotiate and conclude comprehensive agreements in the field of air transport, in all their parts. It also recalls that, in accordance with the jurisprudence of the Court, as reflected in Case C-459/03 (points 92 to 95), the existence of the Union's external competence is not in principle contingent on the adoption of measures of secondary law covering the area in question.
- 3. Therefore, the Commission does not agree that the Union can participate in the negotiations only "as regards matters falling under the exclusive Union competence" (Article 1) nor that negotiating directives on matters covered by Union competence, even if only shared and not yet exercised, could in any way "affect" Member State competences (Article 2).

- 4. The Commission considers moreover that the negotiation of a comprehensive air transport agreement by the Union alone is the most effective way to achieve the objectives of the Common Transport Policy, in particular as regards a common treatment to be granted within the Union to air carriers established in third countries and a common treatment to be granted by third countries to Union air carriers.
- 5. In order for the benefits to be reaped from the international aviation agreements without undue delay, they should apply as soon as possible after their signature. The current practice shows that the participation of Member States in such agreements causes considerably delays in their entry into force, while provisional application is not always ensured in those cases. This is contrary to the interest of the Union. The duty of sincere cooperation (Article 4(3) TEU) requires the institutions and Member States to do everything possible to facilitate the exercise of the Union's powers and to abstain from any measure which could jeopardise the attainment of the objectives of the Treaties.
- 6. The Commission considers moreover that the time limitation of the authorisation(s) is incompatible with the Treaties, and in particular with Article 218(3) TFEU.
- 7. The Commission maintains its view that in the absence of any draft text at this stage Article 218(3) and (4) TFEU provide a sufficient legal basis for the Council Decision, without any substantive legal base being necessary.
- 8. The Commission reserves its right to make use, if necessary, of all the legal means at its disposal to ensure the respect of the provisions of the Treaties."

"Germany agrees to granting a mandate to the Commission to enter into negotiations on a comprehensive air transport agreement with the Republic of Armenia.

However, consent is only given by way of only exception against the background of No 29 of the Riga Summit Joint Declaration of 21/22 May 2015 establishing the Eastern Partnership. It must not be understood as a precedent for the granting of future mandates.

Germany is of the opinion that negotiations should be focused on the agreements for which mandates have already been granted. Statement by the United Kingdom

"The United Kingdom welcomes the approach by the Council to agree legislation relating to the control of new psychoactive substances under Article 83 of Title V of Part III of the Treaty on the Functioning of the European Union.

However, the United Kingdom does not consider that the purported decision by COREPER to modify the legal base for the draft Regulation on new psychoactive substances to Article 83 TFEU triggers the commencement of the three month period allowed for under Article 3 of Protocol (No 21) to the EU Treaties. That period is only commenced where a proposal or initiative has been presented. The purported decision by COREPER to modify the legal basis of a draft Regulation is not such a proposal or initiative and consequently the three month opt in period cannot have been commenced by it."
