Subject:	List of documents issued by each Member State to nationals of third countries who are authorised to reside in the territory of the issuing Member State or in a part of it, but which do not entitle them to move within the Schengen area

This document presents the results of the Presidency's initiative to compile a list of documents issued by each Member State to nationals of third countries who are authorized to reside in the territory of the issuing Member State or in a part of it, but which do not entitle them to move within the Schengen area.

Given the current situation in Europe with regard to migration, it is essential to focus on verifying the identity, rights and obligations of third-country nationals, and as well on the elimination of any possible abuse of 'residence-linked' documents for illegal immigration and/or criminal activities. The objective of the Presidency's initiative is to contribute to addressing current challenges with a view to reducing secondary migration flows. The information has been compiled on the basis of replies from the Member States to the questionnaire set out in the Annex to document 13133/16.

Annex I of this document compiles the replies received by 28 November 2016 from 24 Member States, in alphabetic order of their respective two-letter country code (AT, CH, CY, CZ, DE, EE, ES, FI, GR, HR, HU, IE, LT, LU, LV, MT, NL, NO, PL, PT, RO, SE, SI, and SK). 2 Member States stated that they do not issue documents in question (HR, LU). Annex II lists the legal status / main purpose standard text codes required for question 15.


