- the Commission's indication that it will address the issue in its future communication on CAP modernisation in 2017, as well as of the views expressed by delegations.

- Information from the Presidency on the outcome of the last trilogue
- Exchange of views

The SCA took note of the information from the Presidency on the outcome of the last trilogue on 9 November. The SCA also gave orientations on the two questions outlined in the Presidency Flash. Regarding mutilation (point 1.7.9, Part II of Annex II), a majority of delegations could support the Presidency compromise text, i.e. tail-docking may be exceptionally allowed for sheep only. On derogations for plant reproductive material, a majority of delegations could not support the introduction of a reference to 10 varieties. The Presidency took note of the comments made by delegations and the Commission. The Presidency will take on board the orientations given by the SCA in view of the future negotiations.
