1. AMENDMENTS IN RELATION TO SOUTHERN HORSE MACKEREL

EXPLANATORY NOTE

The South Western Waters and Pelagic Advisory Councils agreed on a management plan for Horse Mackerel (*Trachurus trachurus*) in ICES Division 9. This management plan was deemed precautionary by ICES. A catch option based on the plan was included in the catch options table published as part of the ICES advice on 18 June 2021. In its proposal, the Commission proposed to set the TAC for 2022 in line with that advice. However, both Advisory Councils have since communicated to the Commission, that they wish to amend the management plan to incorporate the recent redefinition by ICES of the fishing mortality value that gives the long-term MSY (F_{MSY}) from 0.11 to 0.15, and that the plan cannot be applied until that amendment is concluded. Until an amended management plan is agreed and assuming that amended plan will still be deemed precautionary by ICES, the Commission proposes that the TAC should be set based on the MSY approach, where catches in 2022 should be no more than 143 505 tonnes. A landing obligation exemption deduction of -4.34% is also applied to that figure, to arrive at a Union quota of 137 277 tonnes.
