

COUNCIL DECISION

on the signing, on behalf of the European Union, and provisional application of the Enhanced Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Kyrgyz Republic, of the other part

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 207 and 209, in conjunction with Article 218(5),

Having regard to the proposal by the European Commission,

Whereas:

- (1) On 21 September 2017, the Council authorised the opening of negotiations with the Kyrgyz Republic for an Enhanced Partnership and Cooperation Agreement.
- Building upon the desire of the Parties to strengthen and widen relations in an ambitious and innovative way, the negotiation of the Enhanced Partnership and Cooperation Agreement (the 'Agreement') was successfully finalised by the initialling of the Agreement on 6 July 2019.
- (3) The Agreement should be signed on behalf of the Union, subject to its conclusion at a later date
- (4) In view of the need to apply the Agreement ahead of its entry into force following ratifications by the Member States, the Agreement should be applied on a provisional basis, pending the completion of the procedures necessary for its entry into force,

HAS ADOPTED THIS DECISION:

Article 1

- 1. The signing of the Enhanced Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Kyrgyz Republic, of the other part, is hereby approved on behalf of the Union, subject to the conclusion of the said Agreement.
- 2. The text of the Agreement to be signed is attached to this Decision.

Article 2

The Council Secretariat General shall establish the instrument of full powers to sign the Agreement, subject to its conclusion, for the person(s) indicated by the Commission.

Article 3

In accordance with Article 318 of the Agreement and subject to the notifications provided for therein, the Agreement shall be applied provisionally between the Union and the Kyrgyz Republic.

This Decision shall enter into force on the date of its adoption.
