The SCA took note of the debriefing of the last trilogue and gave orientations on the Presidency compromise texts on several main outstanding political issues as set out in document 15109/16. The next trilogue will take place on 7 December. An additional SCA meeting is scheduled on 9 December in order to prepare the "Agriculture and Fisheries" Council on 12-13 December. The Ministers will be informed on the state of play of the negotiations.

The Presidency informed the SCA about its intention to send after the exchange of views at the "Agriculture and Fisheries" Council a letter to the President of the "Environment" Council, with copy to Commissioners Hogan and Arias Cañete, containing the political messages regarding the concerns of Agriculture Ministers related to agricultural aspects of these two proposals.

The SCA took note of the information provided by the Commission in response to the request from the Cyprus delegation.

### **7. Organisation of future work**

The Presidency informed the SCA about the "Agriculture and Fisheries" Council of 12 and 13 December 2016, on which occasion a couple of delegations confirmed or informed about AOB requests. The Presidency also confirmed the holding of an additional SCA meeting on 9 December in the afternoon (see point 5).

The future Maltese Presidency informed the SCA about the dates of the first SCA meeting (16 January 2017) and "Agriculture and Fisheries" Council (23 January 2017) under their mandate, and briefly outlined the main priorities of their programme, which will be comprehensively announced during the SCA on 16 January 2017.
