NOTE VERBALE

The Mission of the Kingdom of Norway to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honour to refer to the Agreement between the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, signed on 18 May 1999.

In accordance with Article 8 of the Agreement concerning the Republic of Iceland's and the Kingdom of Norway's association with the implementation, application and development of the Schengen acquis, the Mission of Norway to the EU hereby notifies, on behalf of the Government of Norway, that Norway accepts the content of the following acts according to Article 8 paragraph 2 (c):

- In accordance with Article 8 paragraph 2 (a) of the Agreement concluded by the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, I hereby notify, on behalf of the Government of Norway, the acceptance of the following act:
- REGULATION (EU) 2019/592 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 10 April 2019 amending Regulation (EU) 2018/1806 listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement, as regards the withdrawal of the United Kingdom from the Union.

The Mission of the Kingdom of Norway to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest consideration.
