#### Statement by the Commission

"The Commission considers that the above mentioned "Union submission" to be submitted to the IMO is covered by EU exclusive competence. Submission of proposals to the IMO on issues of EU competence is an act of external representation and should be made by the Commission on behalf of the EU to IMO and should therefore be sent to the IMO by the Commission.

In the view of the Commission, the procedural arguments against presenting submissions to the IMO by the Commission on behalf of the EU are not convincing as there is no evidence to suggest that the IMO, as a specialized agency of the United Nations, would be in a position to reject such a submission.

The Commission thus maintains its position that the Treaty provisions on external representation of the Union should be applied and, consequently, that the only legally correct way forward is to present the submission in question to the IMO by the European Commission on behalf of the European Union. The Commission reserves all its rights in this regard."

#### Statement by Finland

"Finland welcomes the agreement reached between the Council and the Parliament on the Directive establishing the European Electronic Communications Code and the Berec Regulation. Finland fully supports promotion of the Digital Single Market, which is an essential element of the competitiveness of the EU. For Finland, the key aim in the discussions has been to relax and update the currently stringent regulation on telecommunications services. Finland is strongly in favour of the key objectives of the Regulatory Fitness and Performance (REFIT) programme and the better regulation agenda, namely the aim to ensure that EU legislation delivers results for citizens and businesses effectively, efficiently and at minimum cost. We regret to note that the price regulation on Intra-EU Calls is in conflict with these general objectives, as well as the with the modernization and investment objectives of the regulatory framework. First, the price regulation does not reflect a future-proof regulatory approach, particularly as the regulation is applied on services whose usage among consumers is generally in decline. Second, this kind of EU-wide price regulation is unjustified in the market where consumers are provided with a variety of alternatives. The provision of traditional intra-EU calls and SMS is competitive in many Member States. In addition, number-independent interpersonal communications are increasingly popular among consumers, also in the cross-border communications. The price regulation would impose significant technical, commercial and administrative changes to the service-providers without clearly demonstrated wide scale consumer benefit. For these reasons, Finland expresses its disappointment over the agreement to include price regulation of intra-EU calls in the final compromise."

"Despite of its strong commitment with the principle of energy efficiency first, Portugal reaffirms the concerns raised at earlier stages of the negotiation regarding the extremely high level of effort associated to the Article 7 of the Directive."

## Statement by Belgium

"Having voted against does not detract Belgium from being a strong advocate for a sustainable energy and climate policy as laid down in the Council Conclusions of October 2014 and contained in the Paris Agreement. Furthermore, Belgium subscribes fully to the principle of energy efficiency.

The ambitious goal set out in the submitted proposal, more specifically article 7, presents Belgium nonetheless with an unreachable challenge to achieve this in a cost efficient manner.

Notwithstanding, Belgium will continue to deliver constructive contributions to the European energy efficiency goal."

#### Statement by Croatia

"The Republic of Croatia expresses its concerns regarding the provisions of Article 7 and the values of the actual annual savings in the total energy consumption, with the target being set at 0.8 %. The Republic of Croatia could, in accordance with its previously expressed positions agree to support a compromise solution with a maximum 0.7 %.

Although the implementation of energy efficiency measures in all sectors will contribute considerably to the decrease in EU energy consumption, the value of actual annual savings in the total energy consumption of 0.8 % is not economically viable and could have a significant negative economic impact on the Republic of Croatia. Therefore, the Republic of Croatia will abstain when the final compromise text on the proposal for a Directive of the European Parliament and of the Council amending Directive 2012/27/EU will be adopted."

#### Statement by Luxembourg and the Czech Republic

"Luxembourg and the Czech Republic are concerned that the proposed text for the General Approach on the EMIR CCP Supervision proposal will entail additional complexity for the decision-making procedures in the context of the authorization, recognition and supervision of EU and Third Country CCPs. The proposed set-up foreseeing the involvement of colleges and internal ESMA Committees, including, in certain cases, ex ante discussion of decisions, will entail complex interactions between different fora for discussion. Luxembourg and the Czech Republic see a risk that this may lead to delays and inconsistencies which will be detrimental to the overall efficiency of the supervisory decision-making process.

Luxembourg and the Czech Republic furthermore want to underline that in many instances, decisions to be made with regard to the supervision of CCPs can have an important impact for clearing members and clients, and thus on markets, as well as financial stability implications, in Member States other than those where these CCPs are established. Luxembourg and the Czech Republic therefore believe it is important that the experience and insight of these authorities is adequately taken into account in the decision-making process. In this regard, they are concerned that the setting up of internal ESMA Committees with restricted composition may not contribute to well-informed and balanced decision-making.

Luxembourg and the Czech Republic are therefore strong proponents of a simpler, more open and more inclusive approach to supervision. Regulation (EU) No 1095/2010 grants ESMA significant flexibility in deciding the organization that is most appropriate to allow its tasks to be carried out efficiently. Limiting this flexibility in a Level 1 text does not seem to contribute to a more efficient supervisory architecture. To the contrary, an inclusive process for the discussion and drafting of decisions would allow for better sharing of information and experiences and as such would be essential to identifying best practices and fostering convergence.

As regards the recognition of third country CCPs, the Czech Republic and Luxembourg note that the regulatory framework laid down by the proposal on EMIR CCP Supervision will be significantly more complex than the current one. The practical implementation of these new elements will first require a careful assessment by the European Commission and ESMA as to their practical consequences.

Any disruption in access to third country CCPs would have significant negative consequences for clearing members, clients and markets in the EU, including potential implications on financial stability. In order to avoid such disruption, the Czech Republic and Luxembourg believe it is important that recognition decisions adopted pursuant to Article 25 of EMIR remain valid until all the necessary elements required to carry out a recognition process under the reviewed regulatory framework are in place and are thus reviewed only once the new implementing and delegated acts have entered into force.

Luxembourg and the Czech Republic remain committed to discussing these elements in the upcoming trilogue negotiations, in order to ensure that the supervisory framework allows for informed, efficient and balanced decision-making through an inclusive process and in order to guarantee legal certainty for EU clearing members, clients and markets."

#### Statement by the United Kingdom

"We will not support a General Approach on the EMIR CCP proposal as we object to article 25 (7)(f) where third country regulators are required to agree procedures to "assure" the enforcement of ESMA's decisions as part of a memorandum of understanding. This would mean that ESMA's decisions would be binding on third country supervisors. It could require a supervisor to enforce a decision which may conflict with its own domestic requirements and could increase financial stability risks in a stress scenario.

This proposal is unprecedented in supervisory cooperation and is not a workable solution for cross border supervisory and regulatory cooperation for internationally active CCPs. It could become a barrier to market access in the future as third countries are very unlikely to bind their independent supervisors in this way. Given the significant supervisory toolkit available to ESMA under EMIR in relation to third country CCPs – including on-site inspections, fines and withdrawal of recognition – it is unnecessary to require a third-country supervisor to agree to enforce decisions that could potentially conflict with their own statutory objectives. We recognise that with the UK exiting the EU there are valid concerns about the future supervision of UK CCPs with EU users. That is why it is important that the actions of UK and EU authorities are well coordinated and built on foundations of deep cooperation. To that end we support and welcome processes that enable ESMA and the home supervisor to work together.

Additionally, this proposal is unbalanced in the significant powers it gives ESMA and the ECB over non-EU CCPs when they are not given these same powers over EU CCPs. This means ESMA could potentially have powers to "dual supervise" all significant CCPs worldwide except those inside the EU.

To reflect the intention of the co-legislators to give ESMA the tools and flexibility it needs to sign workable MoUs with third country supervisors, article 25(7)(f) should be amended so that the cooperative arrangements between ESMA and third countries authorities specify the procedures for third country authorities to <u>appropriately</u> assure the effective enforcement of decisions adopted by ESMA."
