DECLARATION WITH REGARD TO ICELAND, THE KINGDOM OF NORWAY, THE SWISS CONFEDERATION AND THE PRINCIPALITY OF LIECHTENSTEIN

The Parties to the Agreement between the European Union and Bosnia and Herzegovina on operational activities carried out by the European Border and Coast Guard Agency in Bosnia and Herzegovina take note of the close relationship between the European Union, on the one hand, and Iceland, the Kingdom of Norway, the Swiss Confederation and the Principality of Liechtenstein, on the other hand, particularly by virtue, respectively, of the Agreements of 18 May 1999¹ and 26 October 2004² and the Protocol of 28 February 2008³ concerning the association of those countries with the implementation, application and development of the Schengen acquis.

In such circumstances it is desirable that the authorities of Iceland, the Kingdom of Norway, the Swiss Confederation and the Principality of Liechtenstein, on the one hand, and Bosnia and Herzegovina, on the other hand, conclude, without delay, bilateral agreements on operational activities carried out by the European Border and Coast Guard Agency in Bosnia and Herzegovina in terms similar to those of the Agreement between the European Union and Bosnia and Herzegovina on operational activities carried out by the European Sorder and Coast Guard Agency in Bosnia and Herzegovina on operational activities carried out by the European Border and Coast Guard Agency in Bosnia and Herzegovina.
