Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 186 and 212 in conjunction with Article 218(6), second subparagraph, point (a), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- (1) In accordance with Council Decision (EU) .../...²⁺, the Agreement between the European Union, of the one part, and the Republic of Korea, of the other part, on the participation of the Republic of Korea in Union programmes (the 'Agreement') was signed on ...⁺⁺, subject to its conclusion at a later date.
- (2) Horizon Europe the Framework Programme for Research and Innovation (2021-2027) was established by Regulation (EU) 2021/695 of the European Parliament and of the Council³. In line with the Council's mandate, the Protocol on the Association of the Republic of Korea to Horizon Europe the Framework Programme for Research and Innovation (2021-2027) was negotiated in parallel to the Agreement and, pursuant to Article 17(9) of the Agreement, forms an integral part thereof.
