Sweden supports the Council Conclusions and underlines the importance of ensuring legal ways of entry for persons in need of international protection.

Statement by the Netherlands

The Netherlands is voting against this proposal, because we are of the opinion that promotion measures are not the responsibility of the government, neither the European nor the national government, but a sole responsibility of the sector itself.

Furthermore The Netherlands considers the proposed increase of the budget made available for this objective not acceptable.

Statement by Sweden

Sweden regrets that a clear emphasis on information and promotion measures in third countries is lacking in the Regulation. One of the main objectives of the information provision and promotion measures should be to increase the competitiveness of EU agricultural products outside the Union with a specific focus on those markets in third countries with the highest growth potential.

Sweden also considers that the proposed co-financing rates are being too generous and fear that they will lead to an increased number of unwarranted applications and few programs with added value.

Sweden is also concerned with the information provision and promotion measures relating to alcohol. Sweden considers that promotion measures on alcoholic beverages should be more closely regulated in order to protect public health.

For these reasons Sweden is voting against the proposal.

Statements by the Commission

- 1. The European Commission has already provided guidance on the application of Article 4 of the Directive; transport operations do not have significant impact on international competition if the cross-border use remains limited to two Member States where the existing infrastructure and the road safety requirements allow it. This balances the Member States' right under the principle of subsidiarity to decide on transport solutions suited to their specific circumstances with the need to prevent such policies from distorting the internal market.
- 2. The Commission underlines that it is contrary to the letter and to the spirit of Regulation 182/2011 to invoke Article 5, paragraph 4, second subparagraph, point (b) in a systematic manner. Recourse to this provision must respond to a specific need to depart from the rule of principle which is that the Commission may adopt a draft implementing act when no opinion is delivered. Given that it is an exception to the general rule established by Article 5, paragraph 4, recourse to second subparagraph, point (b) cannot be simply seen as a "discretionary power" of the Legislator, but must be interpreted in a restrictive manner and thus must be justified.

Joint Statement by Finland and Sweden

In accordance with Directive 96/53/EC Member States may authorise on their territories vehicles or vehicle combinations with deviating weights and/or dimensions than the ones listed in Annex I of the Directive. Such vehicles or vehicle combinations should also be allowed to circulate in cross-border operations between Member States. It follows from the economic and internal market objectives that such a transport operation across the border should not be prohibited between two Member States if both authorise it.

The current situation concerning cross-border operations should be safeguarded also in the future. Without legal certainty in this matter, the result may be non-proportional internal market barriers for vehicles circulating between Member States.
