Statement by the Council on DAB No 4/2016

With agreeing to draft amending budget No 4/2016 and the frontloading of the EUR 73.9 million for the provisioning of the EFSI Guarantee Fund, the Council does not pre-empt any decision on Commission proposal COM(2016) 597 final on the extension of the duration of EFSI until 2020. The Council considers this amount to be part financing of the already agreed EFSI package in 2015.

Statement by the Council on fines

Due to the specific circumstances characterising amending budget No 4/2016, the Council takes note that the fines which have already become definitive are not entered into the budget as budgetary revenue. The Council recalls the importance of fines being entered into the budget as budgetary revenue as soon as possible and at the latest in the year following the exhaustion of all legal remedies, in accordance with Article 83 of the Financial Regulation and its rules of application.

The Council invites the Commission to inform the European Parliament and the Council as regularly as possible about fines which may be recorded as budgetary revenue, with a view to improving the predictability of Member States' contributions.

Statement by Austria

With regard to the provisional application by the European Union of the Protocol of Accession to the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part, to take account of the accession of Ecuador, the Republic of Austria declares that it may implement those parts of the Agreement involving competences of the Member States only after all necessary internal procedures for entry into force of the Agreement have been completed. The Republic of Austria will initiate as expediently as possible its internal procedures and will, if any problem arises, consult with the European Commission.

Statement by Ireland

Ireland recalls the statement made by the Council on 31 May 2012 at the occasion of the adoption by the Council of the decision authorising the signature and the provisional application of the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part. The Council's statement noted that:

'Should the implementation of the agreement by the European Union necessitate a recourse to measures pursuant to Part III, Title V, of the Treaty on the Functioning of the European Union, the provisions of the Protocol on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice, annexed to the Treaty on European Union and the Treaty on the Functioning of the European Union, will be fully respected.'

Ireland notes that the Council statement applies also to the accession by Ecuador to the Agreement and notes further that the Commission has, by letter dated 13 October 2016, notified Ecuador of the terms of the Council statement.

Statement by Portugal

Bearing in mind the compliance with the principle of competence sharing between the European Union and its Member States, as established by the Treaties, the Council Decision regarding the provisional application of the Protocol of Accession to the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part, to take account of the Accession of Ecuador, shall not affect the autonomy of Portugal's decisions regarding issues within its national competence, whose international binding to Protocol of Accession, pursuant to its Constitutional principles and rules, depends on the conclusion of the internal ratification procedures and the entry into force of the Protocol of Accession in the international legal system.

Statement by Slovenia

On the basis of the allocation of competences between the European Union and its Member States under the Treaties, the Decision of the Council that authorises the provisional application of the Protocol of Accession to the Agreement between the European Union and its Member States, of one part, and Columbia and Peru, of the other part, to take into account of the Accession of Ecuador, shall not affect the autonomy of the Republic of Slovenia to decide to be bound by it with regard to issues falling within its national competence. That implies inter alia that reference in the said Protocol to internal requirements and procedures necessary for its provisional application is to be understood in the case of Slovenia as referring to the completion of ratification procedures.

Statement by the United Kingdom

The United Kingdom welcomes the signature of the Protocol of Accession to the Trade Agreement between the European Union and its Member States, of the one part, and Colombia and Peru, of the other part, to take account of the Accession of Ecuador.

However, the United Kingdom considers that the Agreement contains provisions related to the temporary presence of natural persons for business which are pursuant to Title V of Part III of the Treaty on the Functioning of the Union. The United Kingdom recalls that, in accordance with Article 2 of Protocol (No. 21) to the Treaties on the position of the United Kingdom and Ireland in Respect of the Area of Freedom, Security and Justice, no provision of any international agreement concluded by the Union pursuant to that Title shall be binding upon or applicable in the United Kingdom unless, in accordance with Article 3 of the Protocol, it notifies its intention that it wishes to take part in the adoption and application of a proposed measure.

As a result, in accordance with Article 3 of Protocol (No. 21), the United Kingdom notified the President of the Council that, to the extent that the Decisions relate to the temporary presence of natural persons for business, it intends to take part in the Council Decisions.

Statement by Greece

Greece regrets that the adoption of the Commission's proposal for a Council Implementing Decision setting out a Recommendation for prolonging temporary internal border control in exceptional circumstances putting the overall functioning of the Schengen area at risk, is based, among others, on the assumption that 'a significant number of irregular migrants (about 60 000) stranded in Greece [who] may reasonably be expected to seek to move irregularly to the other Member States'.

Greece recalls its Follow-up report (12 August 2016) on the implementation of the Action plan on addressing the deficiencies identified in the field of management of its external borders following the evaluation of November 2015, where it presented its well-founded position that no risk of secondary movements from its territory to other EU Member States - such that can pose a threat to the internal security and public order in accordance with the Schengen Borders Code - can be substantiated.

Since the November 2015 evaluation, all border controls and patrols at all BCPs of Greece have been further tightened. Among others, in the framework of the National Operation 'SARISA', Greece has taken all necessary measures to prevent and deter any attempt of absconding from the mainland to the north, including to the former Yugoslav Republic of Macedonia. Furthermore, Greece has requested the deployment of Frontex Guest Officers at the land borders between Greece and Albania and Greece and the former Yugoslav Republic of Macedonia.

Greece believes that the "factual indicators" referred to in recital no.13 of this proposal cannot be adequately substantiated. The repeated mention of what is 'justified to expect' (recital no.5); what 'appears justified' (recital no.12); as well as of those 'who may reasonably be expected to seek to move irregularly to other Member states' (explanatory memorandum, p.3) proves that the proposal is based on speculations and lacks the necessary reasoning for prolonging temporary border controls in accordance to article 29 of the SBC.

Greece further recalls that the information provided by the five Schengen States (Austria, Germany, Denmark, Sweden and Norway) on the internal border controls has been scant and not sufficiently detailed, which is reflected in the 28 September 2016 Commission report on the implementation of the 12 May 2016 Council Recommendation. It, therefore, does not provide solid ground for prolonging temporary border controls.

Greece reiterates that adequate response on behalf of Member States to EASO and FRONTEX calls for experts is key to the success of the implementation of the EU-Turkey Statement.

In addition, the assumptions on the cumulated number of asylum applications received by Schengen States is irrelevant to the subject matter and it does not justify the need for the prolongation of the temporary internal border controls.

Consequently, Greece cannot agree to the proposal for this Council Implementing Decision.

Statement by Hungary

Since the beginning of the migration crisis Hungary is of the opinion that the protection of the external borders is the key in stemming the influx of irregular migrants. We have to ensure that the external borders are crossed only in accordance with rules and regulations.

Hungary is convinced that the draft decision setting out a Recommendation for prolonging temporary internal border control gives an inadequate response to real problems and could lead to the collapse of the Schengen Area.

The draft decision itself highlights that information provided by the 5 Member States show a progressive stabilisation of the situation. The facts and data listed in the draft decision and the figures presented in the report of the European Commission on 28 September 2016 do not justify either the necessity or the proportionality of the maintenance of temporary border controls at the specified internal border sections. Neither the draft decision nor the report of the Commission present any objective evidence with regard to the entry points of the asylum seekers into the territory of the 5 Member States concerned.

The 'Back to Schengen Roadmap' does not provide the legal condition for maintaining the temporary border control at internal borders; however, Hungary agrees with the full implementation of the process of getting 'back to Schengen'.

Internal border control should be limited in scope, frequency, location and time, to what is strictly necessary to respond to the serious threat and to safeguard public policy and internal security, without hampering free movement unduly within the Schengen Area. The relevant Member States should be consulted regularly with a view to ensure that internal border controls are only carried out at those parts of the internal border where it is considered necessary and proportionate and the implementation should be monitored closely by the Commission and the relevant Member States.

Based on the aforementioned circumstances Hungary cannot support the adoption of the draft decision.

Statement by the Commission

When determining the specific terms and conditions regarding the participation of Kosovo in each particular programme in accordance with Article 5 of the Framework Agreement, the Commission will ensure that they are without prejudice to the position of the Union on the status of Kosovo.

Statement by the United Kingdom, Austria, the Czech Republic, France, Croatia, Italy, Sweden and Slovenia

The United Kingdom, Austria, the Czech Republic, France, Croatia, Italy, Sweden and Slovenia would like to place on record their position that only individual Member States have the competence to recognise statehood.

Statement by the United Kingdom

The United Kingdom considers that Protocol 21 to the Treaties on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice is engaged in the proposals for Council Decisions on signature, provisional application and conclusion of the Framework Agreements between the European Union and Kosovo on the general principles for the participation of Kosovo in Union programmes, to the extent that these Decisions relate to the aforementioned state's participation in the Fiscalis 2020 action programme (Regulation 1286/2013) and Customs 2020 action programme (Regulation 1294/2013).

Furthermore, the United Kingdom considers these Council Decisions to be an exercise of the EU's external competence in relation to the various sectoral policies pursued by the underlying programmes. Therefore the substantive legal bases for the underlying programmes should have been cited as the legal bases for these proposed Decisions on signature and conclusion. Where the programmes have justice and home affairs content, the proposed Council Decisions should cite the relevant legal bases from Title V of Part Three TFEU.

Joint statement by France and Sweden

France and Sweden have indicated their agreement to the Council Decision (13791/16 ACP) regarding the amount of the first instalment for 2017 and the annual amount for the same year, and on the ceiling of the contributions to the 11th European Development Fund (EDF) for 2018, taking into account the political priorities set out by the European Council which require the mobilisation of additional funds

However, France and Sweden would like the European Commission to take the following points into consideration:

- recalling our concerns regarding the methods used by the European Commission to establish its disbursement forecasts, we would like the draft Council Decision to set national contributions for 2018 at an appropriate and substantiated amount.
- We invite the European Commission to continue and increase its efforts to actively monitor the implementation of the EDF and to keep the Council informed on budgetary matters. With regard to this last point, the European Commission could usefully:
- regularly share the numerical assumptions used to determine the proposed level of national contributions, in particular the methods number 1 and number 3 of estimating payment needs that were mentioned in Document No 109/16, for which France and Sweden thank the Commission;
- routinely specify, for funding decisions amounting to a substantial total, what impact these are to have on payment forecasts and on the EDF's reserves.

Joint Statement by the Commission and Germany on the option of support for the temporary cessation of fishing activities by the European Maritime and Fisheries Fund (EMFF)

- 1. Point (b) of Article 5(4) of Regulation (EU) 2016/1139 of the European Parliament and of the Council of 6 July 2016 establishing a multiannual plan for the stocks of cod, herring and sprat in the Baltic Sea and the fisheries exploiting those stocks allows the Member States to adopt emergency measures in accordance with Article 13 of Regulation (EU) No 1380/2013 of the European Parliament and of the Council of 11 December 2013 on the Common Fisheries Policy.
- 2. According to the assessment of the International Council for the Exploration of the Sea (ICES), the cod stock in the western Baltic Sea is in a very critical state. The spawning stock biomass of cod is below the spawning stock biomass limit laid down in column B of Annex II to Regulation (EU) 2016/1139. There is an urgent need to adopt corrective measures in order to reach a level above the minimum reference point.
- 3. Germany therefore deems it necessary to adopt emergency measures in accordance with Article 13(1) of Regulation 1380/2013. The emergency measures consist of limitation of fishing activities by additional 30 days for German fishing vessels fishing for cod in Subdivisions 22-24 of as follows: the 30 days in the form of three 10-day blocks which fishermen are free to determine independently within the fishing periods from 1 January to 31 January and from 1 April to 30 June 2017.
- 4. The Commission welcomes the decision of Germany to implement this emergency measure.
- 5. Germany considers that this emergency measure under point (a) of Article 33(1) of Regulation (EU) No 508 /2014 of the European Parliament and of the Council of 15 May 2014 on the European Maritime and Fisheries Fund and repealing Council Regulation (EC) No 2328/2003 is eligible for funding from the EMFF.

Statement by Poland

The compromise text as adopted, which aims to ensure a balanced approach and protect stocks in the Baltic Sea, will demand many sacrifices of and place a heavy burden on the fishing industry.

Poland therefore takes the view that the European Fisheries Fund should accord special protection to coastal fishing, which has a low environmental impact, and which makes an essential contribution towards preserving the cultural heritage of the Baltic Sea region.

Poland would explicitly like to mention the need to adapt the operational programme in such a way as to provide fishermen with additional opportunities for conserving resources in the Baltic Sea.

Furthermore, Poland requests special control of fishing in the Baltic Sea with particular regard to industrial fisheries, which have a significant, negative impact on cod stocks.

Poland would also urge the BALTFISH Presidency to take immediate and decisive action to introduce biological recovery periods for both cod stocks and pelagic species in the Baltic Sea.

Statement by Estonia, Latvia, Lithuania and Poland on Baltic cod

Estonia, Latvia, Lithuania and Poland are of the opinion that the political agreement for the Baltic Sea cod stocks for 2017 is without prejudice to any future discussion on the distribution of stocks and allocation of fishing possibilities between areas. Estonia, Latvia, Lithuania and Poland underscore the importance of maintaining relative stability.

1. Joint statement on the Youth Employment Initiative

The European Parliament, the Council and the Commission recall that reducing youth unemployment remains a high and shared political priority, and to this end they reaffirm their determination to make the best possible use of budgetary resources available to tackle it, and in particular through the Youth Employment Initiative (YEI).

They recall that, in accordance with Article 14(1) of Council Regulation (EU, Euratom) No 1311/2013 of 2 December 2013 laying down the multiannual financial framework for the years 2014-2020 (MFF Regulation), "Margins left available below the MFF ceilings for commitment appropriations for the years 2014-2017 shall constitute a Global MFF Margin for commitments, to be made available over and above the ceilings established in the MFF for the years 2016 to 2020 for policy objectives related to growth and employment, in particular youth employment".

The Council and the European Parliament invite the Commission to propose an amending budget in 2017 in order to provide EUR 500 million for the YEI in 2017 financed by the Global margin for commitments, as soon as the technical adjustment foreseen by Article 6 of the MFF Regulation is adopted.

The Council and the European Parliament undertake to process rapidly the draft amending budget for 2017 put forward by the Commission.

2. Joint statement on payment appropriations

The European Parliament and the Council recall the need to ensure, in the light of implementation, an orderly progression of payments in relation to the appropriations for commitments so as to avoid any abnormal level of unpaid invoices at year-end.

The European Parliament and the Council calls on the Commission to continue monitoring closely and actively the implementation of the 2014-2020 programmes. To that end, they invite the Commission to present in a timely manner, updated figures concerning the state of implementation and estimates regarding payment appropriations requirements in 2017.

The Council and the European Parliament will take any necessary decisions in due time for duly justified needs to prevent the accumulation of an excessive amount of unpaid bills and to ensure that payment claims are duly reimbursed.

3. Joint statement on the 5 % staff reduction

The European Parliament, the Council and the Commission recall the agreement to progressively render 5 % of the staff as in the establishment plan on 1 January 2013, to be applied to all institutions, bodies and agencies, as stated in Point 27 of the Interinstitutional Agreement of 2 December 2013 on budgetary discipline, on cooperation in budgetary matters and on sound financial management.

The three institutions recall that the target year for the full implementation of the 5 % reduction of staff is 2017. They agree that appropriate follow-up measures will be taken to take stock of the situation with a view to ensuring that all efforts are deployed to avoid any additional delays in implementing the 5 % staff reduction target for all institutions, bodies and agencies.

The three institutions welcome the Commission's overview of consolidated data on all external staff employed by the institutions, presented in the draft budget, in line with point (b) of Article 38(3) of the Financial Regulation. They invite the Commission to continue providing this information when presenting its draft budgets for future years.

The Council and the Parliament underline that achieving the 5 % staff reduction target should contribute to savings in the institutions' administrative expenditure. With that in mind, they invite the Commission to start assessing the outcome of the exercise in order to draw lessons for the future.

4. Joint statement on the European Fund for Sustainable Development

In order to address the root causes of migration, the Commission launched the European Fund for Sustainable Development (EFSD) based on the establishment of an EFSD Guarantee and an EFSD Guarantee Fund. The Commission proposes to endow the EFSD Guarantee Fund with EUR 750 million over the period 2017–2020, of which EUR 400 million from the European Development Fund (EDF) over the four years, EUR 100 million from the ENI over 2017–2020 (of which EUR 25 million in 2017), and EUR 250 million of commitment (and payment) appropriations in 2017.

The Council and the European Parliament invite the Commission to request the necessary appropriations in an amending budget in 2017 in order to provide the financing of the EFSD from the EU budget as soon as the legal base is adopted.

The Council and the European Parliament undertake to process rapidly the draft amending budget for 2017 put forward by the Commission.

5. Joint statement on EU Trust Funds and the Facility for Refugees in Turkey

The European Parliament, the Council and the Commission agree that the establishment of Trust Funds and of the Facility for Refugees in Turkey should be transparent and clear, consistent with the principle of unity of the Union budget, with the prerogatives of the budgetary authority, and with the objectives of existing legal bases.

They undertake to address, as appropriate, those issues as part of the revision of the Financial Regulation in order to strike the right balance between flexibility and accountability.

The Commission undertakes to:

- regularly inform the budgetary authority on ongoing and planned Trust Funds' financing (including Member States' contributions) and operations;
- present, as of 2017, a Working Document accompanying the draft budget for the following financial year;
- propose measures for proper involvement of the European Parliament.

6. Joint statement on agriculture

The budget 2017 includes a series of emergency measures to assist farmers in facing the market difficulties experienced recently. The Commission confirms that the margin under heading 2 is sufficient to address possible unforeseen needs. It undertakes to monitor the market situation regularly and to present if needed the appropriate measures to address needs which cannot be covered by the appropriations authorised in the budget. In such a case, the European Parliament and the Council commit to process the relevant budgetary proposals as soon as possible.
