Statement by Hungary

"Hungary acknowledges the importance of structural reforms in achieving sound regulatory and institutional environment and a smoothly-functioning economy across the EU and supports the idea of establishing a more structured way of providing assistance to Member States that deem this necessary for the implementation of their structural reforms.

At the same time the proposal, which establishes the SRSP for the period of 2017-2020, includes several elements with possible long-term impacts on the future of Union policies. Hungary is of the view that the Regulation shall not constitute a precedent for future debates, including on the next Multiannual Financial Framework and prejudge the outcome of them either, with special regard to the financing aspects of SRSP and the definition of "European added value".

Furthermore, Hungary deems it necessary that this support mechanism be established independently from the Cohesion Policy of the European Union and without endangering the policy's objectives enshrined in Article 174 of TFEU (strengthening of the economic, social and territorial cohesion of the EU).

Therefore Hungary is not able to support the Regulation."
