The Council held a policy debate on the above topic on the basis of a discussion paper prepared by the Presidency (doc. 5745/16).

Discussions focused on the balance to be struck between core academic skills, such as literacy and numeracy, and transversal skills such as creativity and problem-solving, as well as on the need for more partnerships between education and business, and on the importance of using and improving existing EU tools, such as the European Qualifications Framework and Europass, particularly given the new waves of migration across the continent.
