On behalf of the President of the European Committee of the Regions (CoR), Vasco Alves Cordeiro, I would like to thank you for your referral request to the CoR, dated 22.12.2022, regarding the following dossier:

Proposal for a Regulation of the European Parliament and of the Council on fees and charges payable to the European Medicines Agency, amending Regulation (EU) 2017/745 of the European Parliament and of the Council and repealing Council Regulation (EC) No 297/95 and Regulation (EU) 658/2014 of the European Parliament and of the Council - COM(2022)0721 - 2022/0417(COD).
