### **Statement by Germany**

"Germany approves the Council Decision, because it agrees with the contents of all envisaged amendments and the competence of the Union regarding the contents of the decision is given in accordance with the rules of Directive 2009/16/EC.

However, Germany is of the opinion that the Paris Memorandum of Understanding on Port State Control – PMoU – is not an international agreement as defined by Title V of the TFEU (Article 216 et seq. TFEU). The PMoU is an administrative agreement and should not be classified as international law, but below it The provisions of Title V of the TFEU are, therefore, not applicable; nor are those of Article 218(9). For this reason, Germany holds the legal opinion that the procedure in accordance with Article 218(9) TFEU cannot be applied to establish the positions to be adopted by the Member States in the Port State Control Committee."

#### **Statement by the Commission**

"With respect to Annex 2 the Commission confirms that it will act within the limits of the powers conferred on it by the Treaties, and in conformity with the procedures, conditions and objectives set out in them. The institutions must exercise their powers with due regard for the powers of the other institutions."
