3. Follow-up to CoP 21 (Climate change)

<u>The Council</u> held a policy debate on the follow-up to COP 21 on the basis of two questions set out in the Presidency headline reading of the Paris Agreement (6006/16) and the Commission communication on "The road from Paris" (6743/16). Following interventions by all delegations and the Commission, the President summarised the debate as follows:

All delegations agreed to the headline reading by the Presidency on the outcome of COP 21 and welcomed the Commission communication on the next steps towards the low carbon transition in the framework of the Energy Union. Many Ministers highlighted the need to maintain the Paris momentum and to focus on the implementation, covering all elements of the Paris outcome, both at international level, but also domestically, in particular in relation to nationally determined contributions (INDCs). Many delegations supported maintaining the EU 2030 climate target to reduce EU greenhouse emissions by at least 40% relative to 1990 emissions and stressed the importance of a timely conclusions of the necessary legislation to meet this target. Some delegations called for an increased ambition. There was a broad support for a thorough EU internal preparation for and active participation in the 2018 facilitative dialogue as well as formulation of a new mid-century low emission development strategy.

<u>The President</u> concluded that the Presidency would reflect further on the Ministers' contributions and will send a letter to the President of the European Council summarising this debate.

<u>The Commission</u> informed the Council that it would adopt the acts regarding the specification of the scientific criteria for the determination of endocrine-disrupting properties by summer 2016.

5. Circular Economy Strategy

The Council held a policy debate on the Circular Economy action plan on the basis of a note from the Presidency, including three questions. Ministers broadly supported the revised package and the objectives of the EU action plan for a circular economy and recognised that a Circular Economy has a lot of potential for green economic growth. Ministers also greatly welcomed the intention to address the production stage of products, in addition to the waste phase, through eco-design principles with a view to increase their durability, reparability and reusability.

The need to address the use of hazardous substances in products with a view to phasing them out was also raised. Synergies with other areas, such as water, climate and bio-economy, were highlighted.

<u>Some delegations</u>, while welcoming ambitious goals, urged to take into account the competitiveness of EU producers as well as the different situations across Member States. In this context, they stressed the importance that the Commission carries out proper Impact Assessments when preparing proposals to implement the measures proposed in the plan.

Creating viable markets for waste and secondary raw materials was considered to be a key prerequisite for a circular economy, while tackling any technical barriers which undermine such markets; ensuring the quality of, and increasing demand for, such materials, through standards and securing a level playing field, was also deemed important.

Information access to consumers was also underlined and the roles of voluntary measures, such as EMAS and Ecolabel, were recognised in this regard; strengthening research and innovation was seen as a crucial step to develop the necessary technologies needed to stimulate the transition to a circular economy; existing financial mechanisms should be used for their uptake. The role of Green Public Procurement was particularly recognised in this context.

Finally, monitoring the transition towards a Circular Economy and reporting on the progress made was given its due recognition, with some Ministers suggesting to do so within existing process, such as the European Semester.

Ministers had an exchange of views on the European Semester/Annual Growth Survey 2016 focussing in particular on the longer term vision, beyond the Europe 2020 strategy. To enable the new 2030 Agenda for Sustainable Development and low carbon and circular economy policies to be successful, integration of these goals should also be considered when designing national and macroeconomic policies. Ministers called for a new and comprehensive strategy covering all dimensions (economic, social, and environmental) beyond the 2020 timeframe. The European Semester, in this context, was seen as a successful monitoring tool.

Adoption of a Council statement

STATEMENT BY THE COUNCIL

Case T-521/14 Sweden v Commission **Judgement of the General Court of 16 December 2015**

"The Council notes that in its judgment of 16 December 2015 in the abovementioned case ¹, the General Court concluded that, by failing to adopt delegated acts as regards the specification of the scientific criteria for the determination of endocrine-disrupting properties, the Commission has failed to fulfil its obligations under Regulation No 528/2012 on biocidal products.

The Council recalls that, in accordance with Article 266 TFEU, the Commission is now required to take the necessary measures to comply with the judgment of the General Court. The Council therefore calls on the Commission to respect its legal obligations, as required by the Treaty and the judgment of the General Court."

STATEMENT BY GERMANY

"The Treaties provide in Art. 216 ff TFEU special rules for international negotiations. Outside these rules the Member States coordinate their negotiation positions within their competences in their own responsibility and outside the organs of the European Union. The Position of the Union is decided in the procedures of the organs of the European Union to the extent that the matter falls within the competence of the Union. In doing so the European Union and its Member States cooperate sincerely in order to possibly be able to speak with one voice. The present paper is according to our view intended to serve exclusively for the negotiations at the seventh meeting of the intergovernmental negotiating committee on the Minamata Convention (INC-7) and does not affect the distribution of substantive competences between the European Union and its Member States."

STATEMENT BY THE COMMISSION

"The Commission confirms that the EU position to be taken at the forthcoming Seventh Session of the Intergovernmental Negotiating Committee of the Minamata Convention on mercury should be adopted pursuant to Article 218(9) of the TFEU. The Commission reserves the right to make use of all the legal means at its disposal to ensure the respect of the provisions of the Treaties."
