Subject:	Proposal for a REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the sustainable management of external fishing fleets, repealing Council Regulation (EC) No 1006/2008
	- Mandate for negotiations with the European Parliament

- 1. On 11 December 2015, the Commission submitted to the European Parliament and the Council a proposal for a Regulation on the sustainable management of external fishing fleets, repealing Council Regulation (EC) No 1006/2008<sup>1</sup>. The proposal envisages an overhaul of the regime of authorisations for Union fishing vessels to fish outside Union waters, and for third country vessels to fish inside Union waters.
- 2. Following examination of the proposal at the level of the preparatory bodies of the Council, the "Agriculture and Fisheries" Council agreed a general approach on 28 June 2016<sup>2</sup>.

- 3. On 2 February 2017, the European Parliament adopted its first-reading position<sup>3</sup>.
- 4. Following an examination of the amendments of the European Parliament and the positions set out in the general approach, the Working Party on Internal and External Fisheries Policy reached, on 2 March 2017, an agreement on a Presidency compromise for a mandate for negotiations with the European Parliament (cf. doc. 6304/2/17 REV 2 PECHE 58 CODEC 211).
- 5. Consequently, <u>COREPER</u> is invited to endorse the mandate as set out in doc. 6304/2/17 REV 2 PECHE 58 CODEC 211 to enable the Presidency to open negotiations with the European Parliament.
