<u>Information Note on statistics on the use</u> <u>of the Internal Market Information system in 2009</u>

Key findings


- (1) More than 4500 authorities at national, regional and local level have been registered as users of the system. Of these authorities 82% are responsible for issues covered by the services directive, 10% for professional qualifications and 8% for both. (see table 1)
- (2) The number of daily users who log into the system for exchange of information, increased from around 40 in January 2009 to almost 200 by the end of last year. Of all requests for information, 57% are accepted within 3 days and 71% are answered within two weeks. (see graph 2 and table 3)
- (3) The volume of requests submitted and received per Member State, in 2009 in the area of professional qualifications, largely reflects current labour migration streams within the EU. (see table 4)
