Suġġett: Riežami/Reviżjoni tal-Qafas Finanzjarju Pluriennali (QFP) għall-2014 - 2020:

Abbozz ta' Regolament tal-Kunsill li jemenda r-Regolament tal-Kunsill (UE, Euratom) Nru 1311/2013 tat-2 ta' Diċembru 2013 li jistabbilixxi l-qafas finanzjarju pluriennali għas-snin 2014-2020

- qbil fil-prinċipju
- talba għall-approvazzjoni tal-Parlament Ewropew
- abbozzi ta' dikjarazzjonijiet

1. F'konformità mal-Artikolu 2 tar-Regolament dwar il-QFP<sup>1</sup>, fl-14 ta' Settembru 2016 il-Kummissjoni adottat Komunikazzjoni dwar ir-riežami/reviżjoni tal-QFP. Din il-Komunikazzjoni kienet akkumpanjata minn diversi proposti legislattivi.

2. Fl-istess jum, il-COREPER inkariga lill-Grupp tal-Hbieb tal-Presidenza (Riežami/Revizjoni tal-QFP)<sup>2</sup> biex jirriežamina l-Komunikazzjoni tal-Kummissjoni, kif ukoll il-proposta li takkumpanjaha ghall-emenda tar-Regolament tal-Kunsill (UE, Euratom) Nru 1311/2013 tat-2 ta' Dicembru 2013 li jistabbilixxi l-qafas finanzjarju pluriennali għas-snin 2014-2020, kif emendat bir-Regolament tal-Kunsill Nru 2015/623 tal-21 ta' April 2015 (*Regolament QFP*); proposta għall-emenda tal-Ftehim Interistituzzjonali tat-2 ta' Dicembru 2013 bejn il-Parlament Ewropew, il-Kunsill u l-Kummissjoni dwar dixxiplina baġitarja, dwar kooperazzjoni fi kwistjonijiet baġitarji u dwar ġestjoni finanzjarja tajba (*FII dwar kwistjonijiet baġitarji*), u proposta għall-emenda tad-Deċiżjoni Nru 2015/435 tal-Parlament Ewropew u tal-Kunsill tas-17 ta' Dicembru 2014 dwar il-mobilizzazzjoni tal-Marġni ta' Kontingenza (*Deċiżjoni dwar il-Marġni ta' Kontingenza*).
3. Wara l-eżami mwettaq fil-livell ta' esperti tal-Komunikazzjoni tal-Kummissjoni u l-proposti msemmijin hawn fuq, il-Kunsill Affarijiet Ĝenerali tal-15 ta' Novembru 2016 ta appoġġ wiesa' għall-elementi li jinsabu fil-kompromess rivedut tal-Presidenza<sup>3</sup>, li kollha huma meqjusa bħala parti minn pakkett. Madankollu, f'dak iż-żmien, delegazzjoni waħda ma kinitx f'pozizzjoni li tipparteċipa fil-ftehim, u delegazzjoni waħda ħabbret li kienet ser tastjeni milli tivvota.
4. Wara li l-kompromess tagħha rċieva appoġġ wiesa' fil-Kunsill, il-Presidenza kellha bosta diskussionijiet informali ma' rappreżentanti mill-Parlament Ewropew, u rrapporat dwar dawn il-kuntatti lid-delegazzjoni fuq bażi regolari. Il-grupp ta' hidma tal-Hbieb tal-Presidenza dwar ir-Riežami/Revizjoni tal-QFP wettaq ukoll segwitu tekniku preliminari biex jiffacilita, jekk u meta jkun possibbli, il-finalizzazzjoni tal-pakkett.
5. Il-pożizzjonijiet espressi fil-15 ta' Novembru 2016 kienu mtennija matul il-Kunsill Affarijiet Ĝenerali tat-13 ta' Dicembru 2016.
6. F'Jannar u fi Frar 2017, il-Presidenza mexxiet diskussionijiet informali, inkluz mad-delegazzjoni li ma kinitx f'pozizzjoni li tipparteċipa fil-ftehim fil-15 ta' Novembru 2016, u kkonkludiet li l-pożizzjoni ta' dik id-delegazzjoni kienet evolviet.

On 14 September 2016, the Commission submitted to the Council a Proposal for a Council Regulation amending Regulation (EU, Euratom) No 1311/2013 laying down the multiannual financial framework for the years 2014-2020 (2016/0283 (APP)), a Proposal for an amendment of the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management (COM (2016) 606 final); and a Proposal for a Decision of the European Parliament and of the Council amending Decision (EU) 2015/435 on the mobilisation of the Contingency Margin (COM (2016) 607 final).

Billi:
