The Commission reassured its strong willingness to achieve an agreement on this file and reminded what was said already at the "Agriculture and Fisheries" Council last December by the Commission's representative - that there should be no red lines. The Commission also pointed out that the issue on seeds is vital for the EP.

- the objections of the Czech Republic, Latvia, Hungary and Austria to the Delegated Regulation, of the reservations of the Danish, German, Italian and UK<sup>1</sup> delegations, of the comments of other delegations, of the Council Legal Service intervention, and of the Commission's response; and of
- the absence of a qualified majority comprising at least twenty-one delegations enabling the Council to object to the Delegated Regulation.

The SCA

- took note of one delegation's comment as well as of the Commission's comments on the procedure to be followed by the Council, including that the Commission was not in a position to submit a proposal at this stage;
- invited the Commission to submit to the Council as soon as possible a proposal for a Council Decision pursuant to Article 218(9) TFEU concerning the position to be adopted on behalf of the Union with respect to the decision of the OIV to grant a particular status to the EU and to include in the proposed Council Decision a reference to the amount of the EU's financial contribution to the OIV budget.
