The Council held an in-depth discussion on EU relations with Africa, covering peace and security, prosperity and partnership. Ministers underlined the need for continued EU support on African capacity building. There was consensus that there are economic as well as political opportunities in Africa. Post-2015, energy, climate change and counter-terrorism were identified as horizontal issues to be taken up with the African representatives on the international scene.

In addition, the Council adopted conclusions on the political situation in Burundi in the pre-electoral context (doc. 7170/15), on the Gulf of Guinea Action Plan 2015 - 2020 (doc. 7168/15), on Mali (doc. 7203/15) and on Ebola (doc. 7200/15).

**STATEMENTS FOR THE COUNCIL MINUTES****Ad "A" item 1:****Relations with Ukraine**

- **Draft Council Decision on the Union position within the Association Council established by the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part and Ukraine, of the other part with regard to the adoption of a Recommendation on the implementation of the EU-Ukraine Association Agenda**

**STATEMENT BY THE UNITED KINGDOM**

"The United Kingdom supports the content of the EU-Ukraine Association Agenda.

The United Kingdom notes that, following the judgment of the Court of Justice in case C-399/12 Germany v Council taken together with the adoption of Regulation 232/2014 establishing a European Neighbourhood Instrument, this Association Agenda has legal effects for the purposes of the Union's internal legal order. Consequently, it is now appropriate for the Union's position in respect of this Association Agenda to be adopted by reference to a Council Decision made pursuant to Article 218(9) TFEU.

However, the United Kingdom wishes to record its understanding that the contents of the Association Agenda, annexed to the Council Decision, being a recommendation to be made by the Association Council set up under the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part and Ukraine, of the other part means that it can only contain political commitments which do not impose new legal obligations on the Parties to that Agreement. The United Kingdom considers its agreement to the method of adoption of this Association Agenda is not a precedent for the adoption of Association Agendas in the future. The method of adopting other Association Agendas will be considered on a case by case basis."

**Ad "A" item 4:**      **Draft Council Decision on the Union position within the Association Council set up by the Euro Mediterranean Agreement establishing an association between the European Communities and their Member States, of the one part, and the Republic of Tunisia, of the other part, with regard to the adoption of a recommendation on the implementation of the EU-Tunisia Action Plan implementing the privileged partnership (2013-2017)**

#### **STATEMENT BY THE CZECH REPUBLIC**

"The Czech Republic wishes to stress the political significance of the 2013-2017 Action Plan and express its full support for the adoption of its content.

However, from the Czech Republic's point of view, Article 218(9) TFEU is not the correct procedural legal basis for the adoption of the 2013-2017 Action Plan, neither for the adoption of similar acts in a similar context, because these constitute important policy documents with political, but not legal effects. The relationship between the mentioned Action Plan and the Regulation (EU) No. 232/2014 establishing a European Neighbourhood Instrument (ENI) cannot change the above stated fact, since it is too vague to cause legal effects of the Action Plan in the sense of the judgement in case C-399/12 *Germany v. Council*. In the view of the Czech Republic, the interpretation given to Article 218(9) by the Court of Justice of the EU in the above referred case cannot be further extended to cover the current situation and the status of the Action Plan or similar political documents adopted in the framework of other association agreements."

#### **STATEMENT BY THE UNITED KINGDOM**

"The United Kingdom supports the content of the EU-Tunisia Action Plan implementing the privileged partnership (2013-17).

The United Kingdom notes that, following the judgment of the Court of Justice in case C-399/12 *Germany v Council* taken together with the adoption of Regulation 232/2014 establishing a European Neighbourhood Instrument, this Action Plan has legal effects for the purposes of the Union's internal legal order. Consequently, it is now appropriate for the Union's position in respect of this Action Plan to be adopted by reference to a Council Decision made pursuant to Article 218(9) TFEU.

However, the United Kingdom wishes to record its understanding that the contents of the Action Plan, annexed to the Council Decision, being a recommendation to be made by the Association Council set up under the Euro Mediterranean Agreement establishing an association between the European Communities and their Member States, of the one part, and the Republic of Tunisia, of the other part, means that it can only contain political commitments which do not impose new legal obligations on the Parties to that Agreement.
