European Parliament legislative resolution of 6 May 2025 on the Council position at first reading with a view to the adoption of a regulation of the European Parliament and of the Council on a Border Regions' instrument for development and growth (BRIDGEforEU) (17102/1/2024 – C10-0057/2025 – 2018/0198(COD))

(Ordinary legislative procedure: second reading)

The European Parliament,

- having regard to the Council position at first reading (17102/1/2024 – C10-0057/2025),
- having regard to the opinions of the European Economic and Social Committee of 19 September 2018¹ and of 24 April 2024²,
- having regard to the opinions of the Committee of the Regions of 5 December 2018³ and of 17 April 2024⁴,
- having regard to its position at first reading⁵ on the Commission proposal to Parliament and the Council (COM(2018)0373– 2018/0198(COD)),
- having regard to the amended Commission proposal (COM(2023)0790),
- having regard to Article 294(7) of the Treaty on the Functioning of the European Union,
- having regard to the provisional agreement approved by the committee responsible under Rule 75(4) of its Rules of Procedure,
- having regard to Rule 68 of its Rules of Procedure,

- having regard to the recommendation for second reading of the Committee on Regional Development (A10-0058/2025),
 - 1. Approves the Council position at first reading;
 - 2. Notes that the act is adopted in accordance with the Council position;
 - 3. Instructs its President to sign the act with the President of the Council, in accordance with Article 297(1) of the Treaty on the Functioning of the European Union;
 - 4. Instructs its Secretary-General to sign the act, once it has been verified that all the procedures have been duly completed, and, in agreement with the Secretary-General of the Council, to arrange for its publication in the *Official Journal of the European Union*;
 - 5. Instructs its President to forward its position to the Council, the Commission and the national parliaments.
